1. Purpose of Report/Introduction

The purpose of this report is to notify the Committee of new supplementation rates set by other local authorities for registered services located in their area. This is in line with a COSLA agreement whereby each local authority sets the supplementation rate for all establishments based in their area. Committee is asked to approve the rates as the basis for payment for North Lanarkshire Council residents placed in these establishments.

2. Background

2.1 Supplementation rates are a charge per client week set for registered Residential and Day Care establishments based in the Voluntary Sector. COSLA agreed that each local authority would set the rate for all establishments based within its own area. These rates are then paid by any authority placing clients in these establishments.
