**COATS HOUSE, AIRDRIE – RELOCATION OF AIRDRIE FIRST STOP SHOP AND REFURBISHMENT WORKS**

7. There was submitted a report dated 8 July 2014 by the Joint Acting Head of Design and Property Services, North Lanarkshire Council, advising that, given that the existing First Stop Shop premises at 10 Bank Street, Airdrie, were no longer suitable to meet the increase in demand for service provision, it was the intention of the Council (1) to create a modern “fit for purpose” First Stop Shop within Coats House, Airdrie; (2) to carry out a programme of works for the partial refurbishment of the building, at an estimated cost in excess of £1m, and (3) to relocate the First Stop Shop Service which was currently located at 10 Bank Street to Coats House.

Thereon, Eric Hislop, Joint Acting Head of Design and Property Services, North Lanarkshire Council, was heard in supplement to the report. Arising out of a brief discussion, it was suggested that a report be submitted to a future meeting of the Partnership on the progress of the development of a First Stop Shop within Coats House, and on the future use of the premises at 10 Bank Street following the relocation of the First Stop Shop Service.

### YOUTH INVESTMENT PROGRAMME

11. With reference to paragraph 12 of the Minute of the meeting of this Local Area Partnership held on 22 January 2014, there was submitted a report (docketed as relative to the Minute of the meeting of Airdrie Area Committee held on 30 July 2014) dated 30 July 2014 by the Head of Planning and Regeneration, North Lanarkshire Council (1) providing an update on the performance of the Council's Youth Investment Programme which offered incentives to employers to recruit young unemployed residents of North Lanarkshire; (2) indicating that, by May 2014, in the third year of the Programme, 4,070 unemployed residents had benefitted from the Programme, and that 1,937 jobs had been secured from the private sector; (3) advising that, to date, 343 unemployed residents in the Airdrie area had been supported into employment, and (4) stating that, while the statistics indicated that the Airdrie area as a whole had secured an appropriate share of youth investment jobs, the results showed that there was a higher rate of youth unemployment in the Airdrie North area compared to the Airdrie Central and Airdrie South areas.
