### **REMIT FROM THE MEETING OF THE POLICY AND RESOURCES COMMITTEE HELD ON 19 SEPTEMBER 2013 - BUDGET SAVINGS: ANALYSIS OF CONSULTATION RESPONSES**

16. With reference to paragraph 16 of the Minute of the meeting of the Policy and Resources Committee held 19 September 2013, when that Committee had considered a report (docketed as relative to the Minute of the meeting of that Committee) dated 28 August 2013 by the Chief Executive, and had agreed inter alia that the report by referred to the Local Area Partnership for information, there was submitted the said report.

Thereon, Stephen Penman, Head of Corporate Communications provided a presentation detailing the outcome of the analysis of the consultation responses and intimated that:-

- 3,250 individuals responded with more than 10,000 comments received on the savings options;
- the Council agreed to 58% of the original savings options totalling £62.4m;
- the savings represented a reduction of 744 full-time equivalent posts over the three years of the programme;
- respondents to the consultation had expressed strong disagreement in relation to 78% of the options and these were subsequently rejected by the Council;

- respondents to the consultation had expressed strong disagreement in relation to 58% of the options and these were subsequently rejected by the Council;
- respondents to the consultation had expressed moderate to slight disagreement in relation to 47% of the options and these were subsequently rejected by the Council;
- respondents to the consultation had expressed more agreement than disagreement in relation to 13% of the options and these were subsequently rejected by the Council;
- respondents to the consultation had expressed strong agreement in relation to 17% of the options and these were subsequently rejected by the Council;
- 18 of the 20 savings options where there was strong disagreement were rejected including proposals such as closure of residential care homes, reducing school transport limits and ceasing school breakfast clubs;
- 17 of the 20 savings options where there was strong agreement were accepted including cessation of the £15 Christmas Gift Scheme and decreasing the number of garden waste collections, and
- it was clear that the savings decisions taken by the Council had been influenced by those who responded and strongly reflected their view and concerns.
