# DECLARATIONS OF INTEREST IN TERMS OF THE ETHICAL STANDARDS IN PUBLIC LIFE ETC. (SCOTLAND) ACT 2000

1. There were no declarations of interest.

The Convener exercised his discretion and varied the Order of Business as hereinafter Minuted.

#### JOINT COMMUNITY SAFETY REPORT

2. With reference to paragraph 10 of the Minute of the meeting of the Wishaw and District Local Area Partnership held on 16 January 2013, there was submitted a report (docketed as relative to the meeting of the Wishaw and District Area Committee held on 17 April 2013) dated 17 April 2013 by the Executive Director of Environmental Services, North Lanarkshire Council (1) highlighting, within Appendix 1 to the report, the information and action which had been considered by the Local Community Safety Sub-Group for the period December 2012 to February 2013, including a statistical analysis of incidents within Ward 20, which had been identified as a priority Ward; (2) providing details of a number of positive initiatives within the Wishaw and District Locality, and (3) intimating, within the report, the performance update with regard to Wards 12 and 19.

Thereon, Brian McGuire, Group Commander, Scottish Fire and Rescue Service, Chief Inspector Bland and Inspector Alex Graham, Police Scotland and Gillian Whitehead, Area Manager, Housing and Social Work Services, North Lanarkshire Council, were heard in full explanation of the report and responded to Members' questions.

Thereafter the Convener intimated his concerns regarding illegal parking of vehicles in various streets within the Town Centre. Inspector Graham advised that two Officers conducted daytime patrols in Wishaw Town Centre and that 60 fixed penalty parking tickets had been issued in the last month. He also advised that the Officers would continue to patrol the area.

Councillor Cefferty questioned the value of Tenant Led Inspections carried out with Housing and Social Work Services and indicated that he had not been informed they were taking place. Gillian Whitehead, Area Manager, Housing and Social Work Services, North Lanarkshire Council indicated that she would forward the Action Plan compiled from the Tenant Led Inspections to any Elected Member who requested it.

**Decided:** that it be recommended to the Area Committee:-

## NHS LANARKSHIRE - NORTH COMMUNITY HEALTH PARTNERSHIP - NORTH EAST UNIT

3. There was submitted a report dated March 2013 by the General Manager, NHS Lanarkshire (1) providing details of various initiatives which had taken place, or would take place, within the Wishaw and District Locality area, and (2) providing details thereon.

Graham Johnston, Project Manager of the New Wishaw NHS/Council Centre, NHS Lanarkshire provided an update on the new Wishaw NHS/Council Centre and advised of all NHS and Council Services which would be housed within the new Centre. He also advised that the new Centre was anticipated to be opened by May 2015 and that further reports on progress would be submitted to future meetings of the Local Area Partnership.

Matt Costello, Local Regeneration Manager, Environmental Services, North Lanarkshire Council outlined the main points of the report and responded to Members' questions.

Thereon, the Convener advised of his concerns that Local Development Programme funding was being used for projects which could be funded through North Lanarkshire Council Services. He suggested that the four secondary schools within the area be contacted and the school pupils consulted regarding their views and ideas on possible projects for their community.

# WISHAW TOWN CENTRE ACTION PLAN - UPDATE

7. With reference to paragraph 7 of the Minute of the meeting of the Wishaw and District Local Area Partnership held on 16 January 2013, when progress in relation to projects contained within the

Wishaw Town Centre Action Plan had been noted, there was submitted a report dated 17 April 2013 by the Head of Planning and Development, North Lanarkshire Council (1) advising of progress made on projects and initiatives contained within the Action Plan; (2) indicating that (a) survey work on a new Town Centre Framework for Wishaw would commence soon, and (b) consultation with a wide range of stakeholders on the development of the new Wishaw Town Centre Framework would commence in May 2013; (3) intimating that Wishaw Town Centre had secured £3m for 2013/14 to 2015/16 for Phase 2 of streetscape improvement works and a further £500k from 2016/17 to 2017/18 for additional public realm works; (4) detailing, within the report, an update with regard to Road and Parking Improvements, Streetscape Improvements, and Town Centre Activities, and (5) informing that (a) the Council was currently looking into the potential for establishing Business Improvement Districts (BID) in North Lanarkshire Town Centres, and (b) the work to engage with Town Centre businesses to raise awareness of BIDs was underway.

Thereon, Lyndsay Noble, Senior Planner, Environmental Services, North Lanarkshire Council was heard in full explanation of the projects and responded to Members' questions.

**Decided:** that it be recommended to the Area Committee:-

- (1) that the progress made on the projects and initiatives contained within the Wishaw Town Centre Action Plan be noted, and

#### RESHAPING CARE FOR OLDER PEOPLE: PROGRESS REPORT

There was submitted a report dated 17 April 2013 by the Executive Director of Housing and Social Work Services providing an update on the progress made in Reshaping Care for Older People across statutory sectors in North Lanarkshire, the Third Sector and Independent Sectors (1) outlining the background to the Government's Policy on Reshaping Care for Older People which was accompanied by a change fund allocation of £3.8m for a period of four years; (2) providing an overview of the progress made to date in respect of community capacity building/preventative and anticipatory care, proactive care and support at home, effective care at times of transition and hospital and institutional care, and (3) summarising the impact of the policy within Wishaw and District locality, including the Locality Partnership Development Programme run through the project "Getting Better Together, Shotts" and the shifting balance of care through the provision of appropriate housing options in respect of respite facilities, sheltered housing complexes and multi-storey towers.

Thereon, Sandra MacKay, Project Manager, Housing and Social Work Services, North Lanarkshire Council was heard in further explanation of the report and responded to Members' questions.
