1. BACKGROUND

At its meeting in January 2012 the Learning and Leisure Services Committee agreed to declare the former Abronhill Nursery School building and site, Hornbeam Road, Cumbernauld surplus to requirements of Learning and Leisure Services.

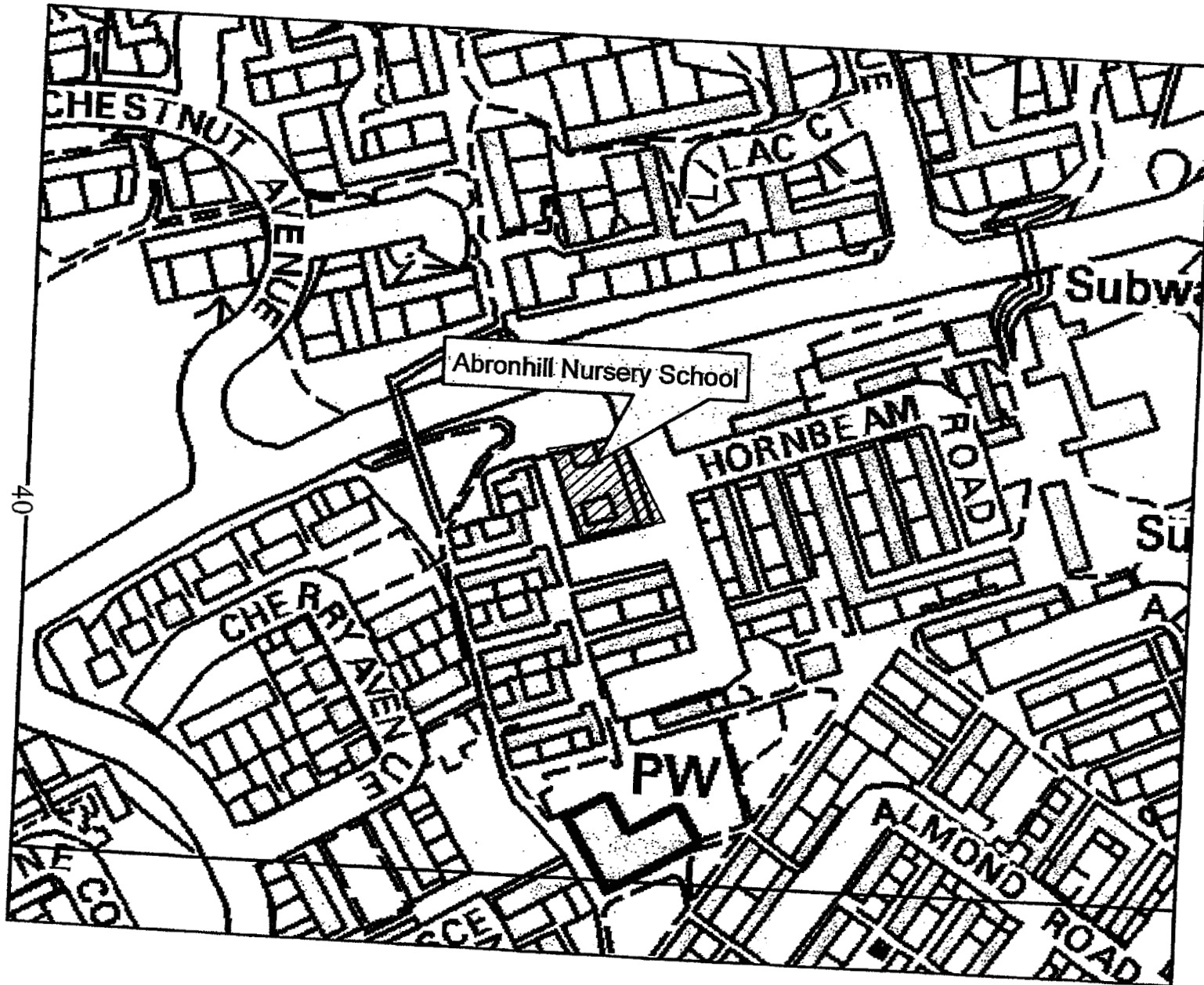
2. CONSIDERATIONS

The committee at its meeting in January 2012 agreed to declare the building and site of the former Abronhill Nursery Centre, Cumbernauld surplus to the operational requirements of Learning and Leisure Services. This area is shown at appendix 1. It is now considered appropriate to declare the site of the play area and garages of the former Abronhill Nursery School, which extend to 273m² or thereby, as shown in the appendix 2 of this report, as being surplus to the requirements of Learning and Leisure Services.

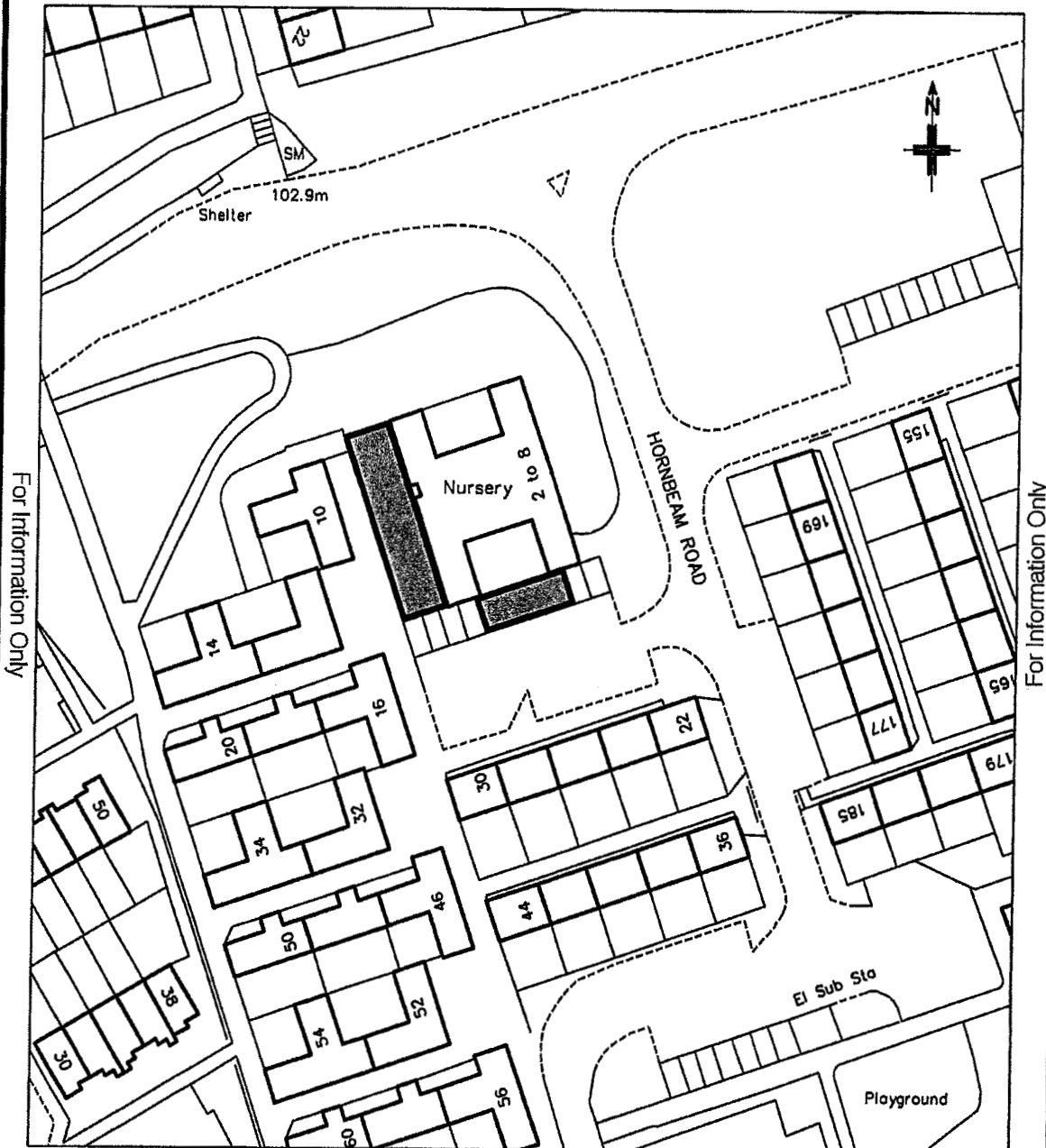
