THE NORTH LANARKSHIRE COUNCIL (GARTFERRY ROAD, MOODIESBURN) (30MPH SPEED LIMIT) ORDER 2006

On 29 June 2006 the North Lanarkshire Council made the above-named Traffic Regulation Order in terms of the Road Traffic Regulation Act 1984.

North Lanarkshire Council
(Gartferry Road, Moodiesburn)
(30 MPH Speed Limit) Order 2006

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 84 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Constable of Strathclyde Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order.

1. This Order may be cited as "The North Lanarkshire Council (Gartferry Road, Moodiesburn) (30 MPH Speed Limit) Order 2006" and shall come into operation on Monday the tenth day of July, two thousand and six.
2. No person shall drive or cause or permit to be driven any motor vehicle at a speed exceeding thirty miles per hour on the lengths of roads specified in Schedule I to this Order.
3. The Strathclyde Regional Council (40mph Speed Limit) Order 1975 will be revoked as part of this order specified in Schedule II to this order.

SCHEDULE I

30 MPH SPEED LIMIT

Length(s) of road in the region of North Lanarkshire

Gartferry Road, Moodiesburn

The length of Gartferry Road, Moodiesburn from a point 377 metres east of the extended line of the east kerb of Glenview Crescent, south westwards then southwards to a point 186.5 metres or thereby, north of its junction with the Main Street, Chryston, a distance of 2666 metres or thereby.

Auchengeich Road, Moodiesburn

The length of Auchengeich Road, Moodiesburn from its junction with Gartferry Road northwards for a distance of 101.5 metres or thereby.
