**(B7066 West Main Street, Harthill)**

**(30 MPH Speed Limit Extension) Order 2007**

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 84 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Constable of Strathclyde Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order.

1. This Order may be cited as "The North Lanarkshire Council (B7066 West Main Street, Harthill) (30 MPH Speed Limit Extension) Order 2007" and shall come into operation on the Fourteenth day of May, Two thousand and seven.
2. No person shall drive or cause or permit to be driven any motor vehicle at a speed exceeding thirty miles per hour on the lengths of roads specified in Schedule I to this Order.
3. The Strathclyde Regional Council (Restricted Roads) (Transitional) Order 1985 and the County of Lanark (40 mph Speed Limit) (No. 2) Order 1973 will require to be amended as specified in Schedule II to this Order.

Length(s) of road in the region of North Lanarkshire

B7066 West Main Street, Harthill

B7066 West Main Street, Harthill from a point 75 metres west of the centre line of Breslin Terrace northeastwards to the boundary between North Lanarkshire and West Lothian, 180 metres east of the extended line of the east kerb of B718 Westcraigs Road, a distance of 1760 metres or thereby

### ORDERS TO BE AMENDED

#### Name of Order

The Strathclyde Regional Council (Restricted Roads) (Transitional) Order 1985

#### Extent of Amendment

Delete from the schedule of the Order (Reference L/B7066-1):-

That section of B7066 (West Main Street) from a point 46m (50yds) west of the centre line of Mossburn Avenue eastwards to the Regional Boundary 180m east of the kerblineline of Westcraigs Road (B718) a distance of 975m or thereby.

#### Name of Order

The County of Lanark (40mph Speed Limit) (No. 2) Order 1973

#### Extent of Amendment

Delete from the schedule of the Order:-

2. That length of the Glasgow-Edinburgh Highway (B7066) at Harthill which extends from a point 82 yards west of the centre line of Breslin Terrace in an easterly direction to a point 50 yards west of the centre line of Mossburn Avenue, a distance of 866 yards or thereby.
