**PROPOSED WEIGHT RESTRICTION ORDER**

The North Lanarkshire Council propose to consider the introduction of a Traffic Regulation Order, the effect of which will make it unlawful for any person to drive or cause or permit to be driven any motor vehicle in excess of 3 tonnes maximum gross weight on Banton Road, Banton from a point 693 metres south-westwards of the extended line of the western kerb of Valleybank, south-westwards for a distance of 139 metres or thereby.

**(Weight Restriction) Order 2009**

The North Lanarkshire Council, in exercise of the powers conferred on them by Sections (1), 2(1) to (3) and Part 1V of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Constable of Strathclyde Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order.

1. This Order may be cited as "The North Lanarkshire Council (Banton Road, Banton) (Weight Restriction) Order 2009" and shall come into operation on Monday, the ninth day of February, Two Thousand and nine.
2. No person shall drive or cause or permit to be driven any motor vehicle in excess of 3 tonnes maximum gross weight on the length of road specified in the Schedule to this Order.

## SCHEDULE I

### **3 TONNE MAXIMUM GROSS WEIGHT RESTRICTION**

Length of road in the region of North Lanarkshire

Banton Road, Banton

That length of Banton Road from a point 693 metres south-westwards of the extended line of the western kerb of Valleybank, south-westwards for a distance of 139 metres or thereby.
