

**NORTH LANARKSHIRE COUNCIL**

**POLLOCK STREET & MERRY STREET, MOTHERWELL**

**PROPOSED PROHIBITION OF DRIVING (AMENDMENT) ORDER**

The North Lanarkshire Council propose to consider the introduction of a Traffic Regulation Order, the effect of which will be to amend the North Lanarkshire Council (Pollock Street & Merry Street, Motherwell) (Prohibition of Driving) Order 2010 as follows: in respect of article 2 (f) of the Order, delete "Taxi vehicles", and, in its place, insert "Taxis and Private Hire vehicles" and which will have the effect of exempting taxis and private hire vehicles from the prohibition of driving on (1) Pollock Street, Motherwell from the extended line of the northern kerb of Merry Street, northwards for a distance of 60 metres or thereby, and (2) Merry Street, Motherwell from the extended line of the eastern kerb of Pollock Street, south-westwards to the extended line of the eastern kerb of Muir Street, a distance of 120 metres or thereby.

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 1(1) and 2(1) to (3) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Constable of Strathclyde Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. This Order may be cited as "The North Lanarkshire Council (Pollock Street & Merry Street, Motherwell) (Prohibition of Driving) (Amendment) Order 2011" and shall come into operation on Monday, the twenty-first day of March, Two thousand and eleven.
2. The North Lanarkshire Council (Pollock Street & Merry Street, Motherwell) (Prohibition of Driving) Order 2010 is hereby amended to add Private Hire Vehicles to the list of those excepted from the provisions of that Order, as detailed in the Schedule of this Order.
