

**NORTH LANARKSHIRE COUNCIL**

**B804 MAIN STREET, DUNBETH ROAD, COLTSWOOD ROAD AND GARTLISTON ROAD, COATBRIDGE**

**PROPOSED 30 MPH SPEED LIMIT ORDER**

The North Lanarkshire Council propose to consider the introduction of a Traffic Regulation Order, the effect of which will be to introduce a 30 miles per hour speed limit on B804 Main Street, Dunbeth Road, Coltswood Road and Gartliston Road, Coatbridge from the point that the B804 Main Street joins the A89 Main Street, north westwards, north eastwards and north westwards to a point 446 metres or thereby, north of the extended line of the northern kerb of the access road to Greenhill Industrial Estate, a distance of 1,836 metres or thereby.

As part of the proposed Order, The Strathclyde Regional Council (Restricted Roads) (Transitional) Order 1985 is hereby amended, to the extent that "L/B804-2-That length of B804 (Main Street, Dunbeth Road, Coltswood Road, Coatbridge) from the north kerbline of the A89 northwards to a point 260 metres north of the centre line of the access to Coatbridge Industrial Estate, a distance of 1,650 metres or thereby" is deleted, where that appeared in the Order.

### **(30 MPH Speed Limit) Order 2014**

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 84 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Constable of Police Scotland in accordance with Part IV of Schedule 9 to the Act, hereby make the following Order:-

1. This Order may be cited as "The North Lanarkshire Council (B804 Main Street, Dunbeth Road, Coltswood Road and Gartliston Road, Coatbridge) (30 MPH Speed Limit) Order 2014" and shall come into operation on Monday, the twenty-fourth day of February, Two thousand and fourteen.
2. No person shall drive or cause or permit to be driven any motor vehicle at a speed exceeding thirty miles per hour on the length of roads specified in Schedule 1 of this Order.
3. The Strathclyde Regional Council (Restricted Roads) (Transitional) Order 1985 is hereby amended, as specified in Schedule 2 of this Order.

## **SCHEDULE 1**

### **30 MPH SPEED LIMIT**

#### **B804 Main Street, Dunbeth Road, Coltswood Road and Gartliston Road, Coatbridge**

From the point that the B804 Main Street joins the A89 Main Street, north westwards, north eastwards and north westwards to a point 446 metres or thereby, north of the extended line of the northern kerb of the access road to Greenhill Industrial Estate, a distance of 1,836 metres or thereby.
