A752 Langmuir Road, Bargeddie
(Temporary Road Closure) Order 2006

On 12 April 2006 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on bridge repair works) on A752 Langmuir Road, Bargeddie from its junction with the Showcase Roundabout to the extended line of the north kerb of the A8 westbound slip road by reason of works being executed on or near that location.

Alternative routes: Vehicles on the north side of the closure should proceed around the Showcase Roundabout and exit on the A8 eastbound slip road, proceed eastwards on A8 to Shawhead Interchange, southwards on A725 North Road, westwards on A8, then southwards on A752 slip road to south side of the closure.

Vehicles on the south side of the closure should proceed on the A8 westbound slip road, proceed westwards on A8 to Baillieston Interchange continuing around and exiting on the A8 eastbound slip road, eastwards on A8, then north-westwards on A752 slip road to the north side of the closure.

Pedestrian access will be maintained at all times.

The Order, which continues the restriction currently in operation at this location by virtue of a similar Order made by the Council on Wednesday, 8 March 2006, and which will only be effective from 1930 hours to 0630 hours each consecutive day, will come into operation at 0630 hours on Friday, 21 April 2006 and will remain in operation until 0630 hours on Friday, 19 May 2006.

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (A752 Langmuir Road, Bargeddie) (Temporary Closure) Order 2006” and continues the restrictions currently in force at this location by virtue of a similar Order made by the Council on Wednesday, the eighth day of March, two thousand and six and shall be effective during the period from 1930 hours to 0630 hours each consecutive day, from 0630 hours on Friday, the twenty-first day of April, Two thousand and six until 0630 hours on Friday, the nineteenth day of May, Two thousand and six.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on bridge repair works) on A752 Langmuir Road, Bargeddie from its junction with the Showcase Roundabout to the extended line of the north kerb of the A8 westbound slip road by reason of works being executed on or near that location.

Alternative routes: Vehicles on the north side of the closure should proceed around the Showcase Roundabout and exit on the A8 eastbound slip road, proceed eastwards on A8 to Shawhead Interchange, southwards on A725 North Road, westwards on A8, then southwards on A752 slip road to south side of the closure.

Vehicles on the south side of the closure should proceed on the A8 westbound slip road, proceed westwards on A8 to Baillieston Interchange continuing around and exiting on the A8 eastbound slip road, eastwards on A8, then north-westwards on A752 slip road to the north side of the closure.

Pedestrian access will be maintained at all times.
