**A8011 Central Way (westbound carriageway), Cumbernauld**

**(Temporary Road Closure) Order 2006**

On 31 May 2006 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on carriageway resurfacing works) on the A8011 Central Way (westbound carriageway) from its junction with the Town Centre East Roundabout to the Town Centre West Roundabout by reason of works being executed on or near that location.

*Alternative routes: Vehicles on the east side of the closure to proceed north-eastwards on A8011 Central Way, south-eastwards on B8054 Lyle Brae, proceed around the roundabout and continue south-eastwards on B8054 Lyle Brae, south-westwards on B8054 Lenziemill Road, north-westwards on B8039 on Jane's Brae, then north-eastwards on A8011 Central Way to the west side of the closure.*

*Vehicles on the west side of the closure to proceed vice versa.*

The Order, which will only be effective between the hours of 2000 on Fridays to 0600 on Mondays, will come into operation at 2000 hours on Friday, 16 June 2006 and will remain in operation until 0600 hours on Monday, 26 June 2006.

### **A8011 Central Way (westbound carriageway), Cumbernauld**

#### **(Temporary Road Closure) Order 2006**

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order, which will only be effective between the hours of 2000 on Fridays to 0600 on Mondays, may be cited as “The North Lanarkshire Council (A8011 Central Way (westbound carriageway)) (Temporary Road Closure) Order 2006” and shall be effective during the period from 2000 hours on Friday, the sixteenth day of June, Two thousand and six until 0600 hours on Monday, the twenty-sixth day of June, Two thousand and six.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on carriageway resurfacing works) on the A8011 Central Way (westbound carriageway) from its junction with the Town Centre East Roundabout to the Town Centre West Roundabout by reason of works being executed on or near that location.

*Alternative routes: Vehicles on the east side of the closure to proceed north-eastwards on A8011 Central Way, south-eastwards on B8054 Lyle Brae, proceed around the roundabout and continue south-eastwards on B8054 Lyle Brae, south-westwards on B8054 Lenziemill Road, north-westwards on B8039 on Jane’s Brae, then north-eastwards on A8011 Central Way to the west side of the closure.*

*Vehicles on the west side of the closure to proceed vice versa*
