

**North Lanarkshire Council**  
**B802 South Bridge Street, Airdrie**  
**(Temporary Road Closure) Order 2006**

On 19 July 2006 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on town centre improvement works) on the B802 South Bridge Street, Airdrie from its junction with Hallcraig Street to its junction with A8010 High Street and East High Street by reason of works being executed on or near that location.

*Alternative routes: Vehicles on the south side of the closure should proceed eastwards on Hallcraig Street and Flowerhill Street, north-westwards on B8053 Bore Road, westwards on A8010 Aitken Street, then south-westwards on Chapel Street and East High Street to the north side of the closure.*

Pedestrian access will be maintained at all times.

The Order, which will only be effective between the hours of 1900 on Saturdays to 2359 hours on Sundays and when sign posted, will come into operation at 1900 hours on Saturday, 29 July 2006 and will remain in operation until 2359 hours on Sunday, 6 August 2006.

**(Temporary Road Closure) Order 2006**

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order, which will only be effective between the hours of 1900 on Saturdays to 2359 hours on Sundays and when sign posted, may be cited as "The North Lanarkshire Council (B802 South Bridge Street, Airdrie) (Temporary Road Closure) Order 2006" and shall be effective during the period from 1900 hours on Saturday, the twenty-ninth day of July, Two thousand and six until 2359 hours on Sunday, the sixth day of August, Two thousand and six.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on town centre improvement works) on the B802 South Bridge Street, Airdrie from its junction with Hallcraig Street to its junction with A8010 High Street and East High Street by reason of works being executed on or near that location.

*Alternative routes: Vehicles on the south side of the closure should proceed eastwards on Hallcraig Street and Flowerhill Street, north-westwards on B8053 Bore Road, westwards on A8010 Aitken Street, then south-westwards on Chapel Street and East High Street to the north side of the closure.*

Pedestrian access will be maintained at all times.
