

North Lanarkshire Council
Gartferry Road, Moodiesburn
(Temporary Closure) Order 2006

On 21 September 2006 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on road reconstruction works and emergency service vehicles) on Gartferry Road, Moodiesburn from the east side of the roundabout at Westdale Drive/Glenview Crescent/Gartferry Road eastwards to its junction with Mollins Road by reason of works being executed on or near that location.

Alternative routes: Vehicles on the west side of the closure to proceed around the roundabout exiting on Gartferry Road, southwards Stoneyetts Road, north-eastwards on A80 Cumbernauld Road, north-westwards and westwards on Mollinsburn off slip road and south-westwards on Mollins Road to the east side of the closure.

Vehicles on the east side of closure at Mollins Road to proceed vice versa.

Vehicular access to adjacent properties will be maintained from at least one end of the closure throughout the period of works.

Pedestrian access will be maintained through the works at all times.

The Order will come into operation at 0800 hours on Sunday, 1 October 2006 and will remain in operation until 1700 hours on Friday, 24 November 2006.

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Gartferry Road, Moodiesburn) (Temporary Closure) Order 2006” and shall be effective during the period from 0800 hours on Sunday, the first day of October two thousand and six until 1700 hours on Friday, the twenty-fourth day of November, Two thousand and six.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on road reconstruction works and emergency service vehicles) on Gartferry Road, Moodiesburn from the east side of the roundabout at Westdale Drive/Glenview Crescent/Gartferry Road eastwards to its junction with Mollins Road by reason of works being executed on or near that location.

Alternative routes: Vehicles on the west side of the closure to proceed around the roundabout exiting on Gartferry Road, southwards Stoneyetts Road, north-eastwards on A80 Cumbernauld Road, north-westwards and westwards on Mollinsburn off slip road and south-westwards on Mollins Road to the east side of the closure.

Vehicles on the east side of the closure at Mollins Road to proceed vice versa.

Vehicular access to adjacent properties will be maintained from at least one end of the closure throughout the period of works.

Pedestrian access will be maintained through the works at all times.
