(Temporary Road Closure) Order 2006

On 9 August 2006 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on repair works to damaged road gully) on Netherton Road, Wishaw from its junction with Netherton Street to its junction with B754 Castlehill Road by reason of works being executed on or near that location.

Alternative routes: vehicles on the northwest side of the closure should proceed northwards on Netherton Street, south-eastwards on Alexander Street, southwestwards on B7032 Caledonian road to the south-east side of the closure. Vehicles on the south-east side of the closure should proceed vice versa.

Vehicular access to properties on Netherton Road to be maintained on arrangement with the contractor. Pedestrian access will be maintained at all times.

The Order, will come into operation at 0001 hours on Monday, 21 August 2006 and will remain in operation until 2359 hours on Sunday, 17 September 2006.

(Temporary Road Closure) Order 2006

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Netherton Road, Wishaw) (Temporary Road Closure) Order 2006” and shall be effective during the period from 0001 hours on Monday, the Twenty-first of August, Two thousand and six until 2359 hours on Sunday, the seventeenth day of September, Two thousand and six.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on repair works to damaged road gully) on Netherton Road, Wishaw from its junction with Netherton Street to its junction with B754 Castlehill Road by reason of works being executed on or near that location.

Alternative routes: vehicles on the northwest side of the closure should proceed northwards on Netherton Street, south-eastwards on Alexander Street, southwestwards on B7032 Caledonian road to the south-east side of the closure. Vehicles on the south-east side of the closure should proceed vice versa.
