

**North Lanarkshire Council**

**Biggar Road, Cleland**

**(Temporary Road Closure) Order 2006**

On 20 September 2006 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on carriageway reconstruction works) on Biggar Road, Cleland from a point 400metres or thereby, southeast of its junction with (B7066) High Street, continuing south-eastwards for a distance of 270metres or thereby by reason of works being executed on or near that location.

Appropriate diversion signing will be in place advising drivers of the restrictions associated with the carriageway reconstruction works at this location and the closure will only be valid when the appropriate signing is in place.

*Alternative routes: Vehicles on the northwest side of the closure should proceed north-westwards on Biggar Road, north-eastwards on (B7066) High Street, northwards on (B7066) Motherwell Road, south-eastwards on (A73) Carlisle Road, south-westwards and westwards on Windyedge Road, then north-westwards on Biggar Road to the southeast side of the closure.*

*Vehicles on the southeast side of the closure to proceed vice-versa.*

Pedestrian access will be maintained at all times.

Vehicular access to adjacent premises will be maintained, where possible, by arrangement with the contractor during the closure.

The Order, will come into operation at 0001 hours on Monday, 2 October 2006 and will remain in operation until 2359 hours on Sunday, 24 December 2006.

**(Temporary Road Closure) Order 2006**

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as "The North Lanarkshire Council (Biggar Road, Cleland) (Temporary Road Closure) Order 2006" and shall be effective during the period from 0001 hours on Monday, the second day of October Two thousand and six until 2359 hours on Sunday, the twenty fourth day of December Two thousand and six.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on carriageway reconstruction works) on Biggar Road, Cleland from a point 400metres or thereby, southeast of its junction with (B7066) High Street, continuing south-eastwards for a distance of 270metres or thereby by reason of works being executed on or near that location.

Appropriate diversion signing will be in place advising drivers of the restrictions associated with the carriageway reconstruction works at this location and the closure will only be valid when the appropriate signing is in place.

*Alternative routes: Vehicles on the northwest side of the closure should proceed north-westwards on Biggar Road, north-eastwards on (B7066) High Street, northwards on (B7066) Motherwell Road, south-eastwards on (A73) Carlisle Road, south-westwards and westwards on Windyedge Road, then north-westwards on Biggar Road to the southeast side of the closure.*

*Vehicles on the southeast side of the closure to proceed vice-versa.*

Pedestrian access will be maintained at all times.

Vehicular access to adjacent premises will be maintained, where possible, by arrangement with the contractor during the closure.
