

**North Lanarkshire Council**  
**Sunnyside Road, Coatbridge**  
**(Temporary Closure) Order 2006**

On 8 November 2006 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on Scottish Water mains rehabilitation works) on Sunnyside Road from its junction with the Main Street, A89 South Circular Road, A89 Bank Street and West Canal Street roundabout to the extended line of the south kerb of Baird Street by reason of works being executed on or near that location.

*Alternative routes: Vehicles on the south side of the closure should proceed south-eastwards on the A89 South Circular Road, westwards on the B804 Main Street, north-westwards and northwards on the B804 Dunbeth Road and westwards then south-westwards on B803 Sunnyside Road to the north side of the closure.*

*Vehicles on the north side of the closure should proceed vice versa.*

*Pedestrian access will be maintained at all times.*

*Vehicular access to properties will be maintained by arrangement where practical.*

The Order, will come into operation at 0001 hours on Monday, 20 November 2006 and will remain in operation until 2359 hours on Sunday, 17 December 2006.

**(Temporary Closure) Order 2006**

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Sunnyside Road, Coatbridge) (Temporary Closure) Order 2006” and shall be effective during the period from 0001 hours on Monday, the twentieth day of November, Two thousand and six, until 2359 hours on Sunday, the seventeenth day of December, Two thousand and six.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on Scottish Water mains rehabilitation works) on Sunnyside Road from its junction with the Main Street, A89 South Circular Road, A89 Bank Street and West Canal Street roundabout to the extended line of the south kerb of Baird Street by reason of works being executed on or near that location.

*Alternative routes: Vehicles on the south side of the closure should proceed south-eastwards on the A89 South Circular Road, westwards on the B804 Main Street, north-westwards and northwards on the B804 Dunbeth Road and westwards then south-westwards on B803 Sunnyside Road to the north side of the closure.*

*Vehicles on the north side of the closure should proceed vice versa.*

*Pedestrian access will be maintained at all times.*

*Vehicular access to properties will be maintained by arrangement where practical.*
