(Temporary Closure) Order No. 3 2006

On 14 February 2007 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on Scottish Water's flood alleviation scheme) on Wallace Street from its junction with Dundyvan Road to its junction with Hozier Street by reason of works being executed on or near this location.

Alternative routes: Vehicles on the north side of the closure should proceed north-westwards on Dundyvan Road, south-westwards then south-eastwards on Barrowfield Street, north-eastwards on Newlands Street and eastwards on Hozier Street to the south side of the closure.

Vehicles on the south side of the closure should proceed vice versa.

Vehicular access to properties will be maintained by arrangement where practical.

Pedestrian access will be maintained.

The Order, which continues the restrictions currently in operation at this location by virtue of a similar Order made by the Council on Wednesday, 13 December 2006, which will only be effective when displayed by signs, will come into operation at 2359 hours on Sunday, 25 February 2007 and will remain in operation until 2359 hours on Sunday, 4 March 2007.

(Temporary Closure) Order No 3 2006

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order which may be cited as “The North Lanarkshire Council (Wallace Street, Coatbridge) (Temporary Closure) Order No 3 2006” and continues the restrictions currently in force at this location by virtue of a similar Order made by the Council on 13 December 2006 and shall be effective during the period from 2359 hours on Sunday, the twenty-fifth day of February, two thousand and seven until 2359 hours on Sunday, the fourth day of March, two thousand and seven.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on Scottish Water’s flood alleviation scheme) on Wallace Street from its junction with Dundyvan Road to its junction with Hozier Street by reason of works being executed on or near this location.

Alternative routes: Vehicles on the north side of the closure should proceed north-westwards on Dundyvan Road, south-westwards then south-eastwards on Barrowfield Street, north-eastwards on Newlands Street and eastwards on Hozier Street to the south side of the closure.

Vehicles on the south side of the closure should proceed vice versa.
