**Kirkshaws Road & Woodside Street, Coatbridge**

**(Temporary Closure) Order 2007**

On 13 June 2007 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on carriageway reconstruction works) on Kirkshaws Road and Woodside Street, Coatbridge from the junction of Woodside Street with Old Monkland Road southwards and then south-eastwards on Kirkshaws Road for a distance of 440 metres or thereby by reason of works being executed on or near those locations.

*Alternative routes: Vehicles on the east side of the closure should proceed south-eastwards on Kirkshaws Road north-eastwards and northwards on A725 Whifflet Street and south-westwards on School Street and Old Monkland Road to the north side of the closure.*

*Vehicles on the north side of the closure should proceed vice versa.*

*Diversions routes will be signposted.*

Pedestrian access will be maintained.

Access to properties within the closure will be maintained where practicable by arrangement with the contractor.

The Order will come into operation at 0001 hours on Saturday, 30 June 2007 and will remain in operation until 2359 hours on Monday, 13 August 2007.

**(Temporary Closure) Order 2007**

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Kirkshaws Road & Woodside Street, Coatbridge) (Temporary Closure) Order 2007” and shall be effective during the period from 0001 hours on Saturday, the thirtieth day of June, two thousand and seven until 2359 hours on Monday, the thirteenth day of August, Two thousand and seven.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on carriageway reconstruction works) on Kirkshaws Road and Woodside Street, Coatbridge from the junction of Woodside Street with Old Monkland Road southwards and then south-eastwards on Kirkshaws Road for a distance of 440 metres or thereby by reason of works being executed on or near those locations.

*Alternative routes: Vehicles on the east side of the closure should proceed south-eastwards on Kirkshaws Road north-eastwards and northwards on A725 Whifflet Street and south-westwards on School Street and Old Monkland Road to the north side of the closure.*

*Vehicles on the north side of the closure should proceed vice versa.*

*Diversions routes will be signposted.*

Pedestrian access will be maintained.

Access to properties within the closure will be maintained where practicable by arrangement with the contractor.
