### Kennihill, Airdrie

#### (Temporary Closure) Order 2007

On 11 July 2007 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on the installation of traffic calming works) on Kennihill, Airdrie by reason of works being executed on or near the undernoted locations.

##### Location 1

Kennihill from the extended north kerbline of South Commonhead Avenue to the extended south kerbline of Wellside Avenue.

*Alternative routes: Vehicles on the south side of the closure should proceed eastwards then north-eastwards on South Commonhead Avenue, north-westwards on Thrashbush Road, westwards on Roughcraig Street, southwards on Kennihill to the north side of the closure.*

*Vehicles on the north side of the closure should proceed vice versa.*

##### Location 2

Kennihill from the extended north kerbline of Wellside Avenue to the extended south kerbline of Kennihill Quadrant.

*Alternative routes: Vehicles on the south side of the closure should proceed southwards on Kennihill, eastwards then north-eastwards on South Commonhead Avenue, north-westwards on Thrashbush Road, westwards on Roughcraig Street, southwards on Kennihill to the north side of the closure.*

*Vehicles on the north side of the closure should proceed vice versa.*

##### Location 3

Kennihill from the extended north kerbline of Kennihill Quadrant to the extended south kerbline of Roughcraig Street.

*Alternative routes: Vehicles on the south side of the closure should proceed southwards on Kennihill, eastwards then north-eastwards on South Commonhead*

*Avenue, north-westwards on Thrashbush Road, westwards on Roughcraig Street to the north side of the closure.*

*Vehicles on the north side of the closure should proceed vice versa.*

#### Location 4

Kennihill from the extended north kerbline of Roughcraig Street to the extended south kerbline of Rochsoles Drive.

*Alternative routes: Vehicles on the south side of the closure should proceed north-eastwards on Roughcraig Street, northwards on Thrashbush Quadrant, eastwards, southwards then westwards on Rochsoles Drive and southwards on Rochsoles Crescent to the north side of the closure.*

*Vehicles on the north side of the closure should proceed vice versa.*

#### Location 5

Rochsoles Drive from the extended west kerbline of Rochsoles Crescent southwards for a distance of 39 metres or thereby.

*Alternative routes: Vehicles on the south side of the closure should proceed southwards on Kennihill, north-eastwards on Roughcraig Street, northwards on Thrashbush Quadrant, westwards, southwards and westwards on Rochsoles Drive to the north side of the closure.*

Pedestrian access will be maintained.

Vehicular access to properties will be maintained by arrangement where practical.

It should be noted that under no circumstances will any of the lengths of road be permitted to be closed simultaneously.

The Order, will come into operation at 0001 hours on Saturday, 21 July 2007 and will remain in operation until 2359 hours on Sunday, 19 August 2007.

#### (Temporary Closure) Order 2007

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Kennihill, Airdrie) (Temporary Closure) Order 2007” and shall be effective during the period from 0001 hours on Saturday, the twenty-first day of July, two thousand and seven until 2359 hours on Sunday, the nineteenth day of August, two thousand and seven.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on the installation of traffic calming works) on Kennihill, Airdrie by reason of works being executed on or near the undernoted locations.

#### Location 1

Kennihill from the extended north kerbline of South Commonhead Avenue to the extended south kerbline of Wellside Avenue.

*Alternative routes: Vehicles on the south side of the closure should proceed eastwards then north-eastwards on South Commonhead Avenue, north-westwards on Thrashbush Road, westwards on Roughcraig Street, southwards on Kennihill to the north side of the closure.*

*Vehicles on the north side of the closure should proceed vice versa.*

#### Location 2

Kennihill from the extended north kerbline of Wellside Avenue to the extended south kerbline of Kennihill Quadrant.

*Alternative routes: Vehicles on the south side of the closure should proceed southwards on Kennihill, eastwards then north-eastwards on South Commonhead Avenue, north-westwards on Thrashbush Road, westwards on Roughcraig Street, southwards on Kennihill to the north side of the closure.*

*Vehicles on the north side of the closure should proceed vice versa.*

#### Location 3

Kennihill from the extended north kerbline of Kennihill Quadrant to the extended south kerbline of Roughcraig Street.

*Alternative routes: Vehicles on the south side of the closure should proceed southwards on Kennihill, eastwards then north-eastwards on South Commonhead Avenue, north-westwards on Thrashbush Road, westwards on Roughcraig Street to the north side of the closure.*

*Vehicles on the north side of the closure should proceed vice versa.*

#### Location 4

Kennihill from the extended north kerbline of Roughcraig Street to the extended south kerbline of Rochsoles Drive.

*Alternative routes: Vehicles on the south side of the closure should proceed north-eastwards on Roughcraig Street, northwards on Thrashbush Quadrant, eastwards, southwards then westwards on Rochsoles Drive and southwards on Rochsoles Crescent to the north side of the closure.*

*Vehicles on the north side of the closure should proceed vice versa.*

#### Location 5

Rochsoles Drive from the extended west kerbline of Rochsoles Crescent southwards for a distance of 39 metres or thereby.

*Alternative routes: Vehicles on the south side of the closure should proceed southwards on Kennihill, north-eastwards on Roughcraig Street, northwards on Thrashbush Quadrant, westwards, southwards and westwards on Rochsoles Drive to the north side of the closure.*

Pedestrian access will be maintained.

Vehicular access to properties will be maintained by arrangement where practical.

It should be noted that under no circumstances will any of the lengths of road be permitted to be closed simultaneously.
