New Craig Road/Robberhall Road, Motherwell

(Temporary Road Closure) Order 2007

On 9 August 2007 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on Road Crossing Works) on New Craig Road/Robberhall Road, Motherwell for its entirety by reason of works being executed on or near that location.

Alternative routes: Vehicles on the south side of the closure wishing to access the north side of the closure should proceed westwards on Craigneuk Street, westwards then north westwards on Windmillhill Street, north westwards on Brandon Street, north westwards on Mentieth Road and north eastwards on Merry Street to the north side of the closure.

Vehicles on the north side of the closure wishing to access the south side of the closure should proceed vice versa.

The Order will come into operation at 0001 hours on Monday 20 August 2007 and will remain in operation until 2359 hours on Sunday 16 September 2007.

(Temporary Road Closure) Order 2007

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (New Craig Road, Motherwell) (Temporary Road Closure) Order 2007” and shall be effective during the period from 0001 hours on Monday, the twentieth day of August two thousand and seven until 2359 hours on Sunday, the Sixteenth day of September, Two thousand and seven.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on Road Crossing Works) on New Craig Road/Robberhall Road, Motherwell for its entirety by reason of works being executed on or near that location.

Alternative routes: Vehicles on the south side of the closure wishing to access the north side of the closure should proceed westwards on Craigneuk Street, westwards then north westwards on Windmillhill Street, north westwards on Brandon Street, north westwards on Mentieth Road and north eastwards on Merry Street to the north side of the closure.

Vehicles on the north side of the closure wishing to access the south side of the closure should proceed vice versa.
