Vickers Street/Salisbury Crescent, Motherwell

(Temporary Road Closure) Order 2007

On 27 September 2007 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on road crossings and carriageway re-surfacing works) on the undernoted roads by reason of works being executed on or near those locations.

Phase 1

Vickers Street, Motherwell - from the extended line of the western kerb of Albans Crescent westwards to the extended line of the western kerb of Salisbury Crescent.

Alternative route: Vehicles on the east side of the closure wishing to travel to the west side of the closure should proceed northwards on Albans Crescent, westwards on Watling Street and southwards on Salisbury Crescent to the west side of the closure.

Vehicles on the west side of the closure wishing to travel to the east side of the closure should proceed vice versa.

Phase 2

Salisbury Crescent, Motherwell - for its entirety

Alternative route: Vehicles on the south side of the closure wishing to travel to the north side of the closure should proceed eastwards on Vickers Street, northwards on Albans Crescent and westwards on Watling Street to the north side of the closure.

Vehicles on the north side of the closure wishing to travel to the south side of the closure should proceed vice versa.

The Order will come into operation at 1600 hours on Friday 12 October 2007 and will remain in operation until 2359 hours on Sunday 17 February 2008.

(Temporary Road Closure) Order 2007

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as "The North Lanarkshire Council (Fort Street/Salisbury Crescent, Motherwell) (Temporary Road Closure) Order 2007" and shall be effective during the period from 1600 hours on Friday the twelfth day of October, two thousand and seven until 2359 hours on Sunday the seventeenth day of February, two thousand and eight.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on road crossing and carriageway re-surfacing works) on or by reason of works being executed on or near those locations.

Phase 1

Vickers Street, Motherwell - from the extended line of the western kerb of Albans Crescent westwards to the extended line of the western kerb of Salisbury Crescent.

Alternative route: Vehicles on the east side of the closure wishing to travel to the west side of the closure should proceed northwards on Albans Crescent, westwards on Watling Street and southwards on Salisbury Crescent to the west side of the closure.

Vehicles on the west side of the closure wishing to travel to the east side of the closure should proceed vice versa.

Phase 2

Salisbury Crescent, Motherwell - for its entirety

Alternative route: Vehicles on the south side of the closure wishing to travel to the north side of the closure should proceed eastwards on Vickers Street, northwards on Albans Crescent and westwards on Watling to the north side of the closure.

Vehicles on the north side of the closure wishing to travel to the south side of the closure should proceed vice versa.
