### A73 Stirling Road & Lenziemill Road, Cumbernauld

# (Temporary Closures) Order 2007

On 24 October 2007 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on remedial works, antiskid and road markings and emergency vehicles) on the undernoted roads by reason of works being executed on or near those location.

### Closure 1

A73 Stirling Road from the extended line of the west kerb of Auchenkilns Road southeastwards to the start of the northbound off-slip road leading to Blackbog Road.

Alternative routes: Vehicles on the southeast side of the closure wishing to travel to the north-west side of the closure should proceed northwards on the un-named off-slip road to Blackbog Road, eastwards on Blackbog Road, northwards and north-eastwards on B8039 Stirling Road, north-westwards and northwards on Blairlinn Road, north-westwards on B8039 Jane's Brae, westwards on A8011 Glasgow Road, northwestwards on the un-named slip road and un-named link road to Back 'O' Hill Roundabout, eastwards and south-eastwards on B8048 Kirkintilloch Road and southeastwards on A73 Stirling Road to the northwest side of the closure.

Vehicles on the northwest side of the closure wishing to travel to the A73, south-east of the closure should proceed north-westwards on A73 Stirling Road, north-westwards and westwards on B8048 Kirkintilloch Road, south-eastwards on the un-named link road and un-named slip road from Back 'O' Hill Roundabout to the A8011 Glasgow Road, eastwards on the A8011 Glasgow Road, south-eastwards on B8039 Jane's Brae, southwards and south-eastwards on B8039 Blairlinn Road and south-westwards and southwards on B8039 Stirling Road to the A73.

Vehicles on the southeast side of the closure wishing to travel to Lenziemill Road should proceed northwards on the un-named off-slip road to Blackbog Road, eastwards on Blackbog Road, northwards and north-eastwards on B8039 Stirling Road, north-westwards and northwards on Blairlinn Road to Lenziemill Road.

Vehicles on the northwest side of the closure wishing to travel to Lenziemill Road should proceed north-westwards on A73 Stirling Road, north-westwards and westwards on B8048 Kirkintilloch Road, south-eastwards on the un-named link road and unnamed slip road from Back 'O' Hill Roundabout to the A8011 Glasgow Road

eastwards on the A8011 Glasgow Road and south-eastwards on B8039 Jane's Brae to Lenziemill Road.

### Closure 2

Lenziemill Road from its junction with the A73 Stirling Road north-eastwards to the extended line of the south-west kerb of the access to the Greenfaulds Station, Park and Ride.

Alternative routes: Vehicles on the north-east side of the closure wishing to travel to the A73, south east of the closure should proceed north-eastwards on Lenziemill Road, southwards and south-eastwards on B8039 Blairlinn Road and southwestwards and southwards on B8039 Stirling Road to the A73.

Vehicles on the north-east side of the closure wishing to travel to the A73 or A80, northwest of the closure should proceed north-eastwards on Lenziemill Road, northwestwards on B8039 Jane's Brae, westwards on A8011 Glasgow Road, northwestwards on the un-named slip road and un-named link road to Back 'O' Hill Roundabout and eastwards and south-eastwards on B8048 Kirkintilloch Road to the A73 and A80

Pedestrian access will be permitted.

Both roads will be closed at the same time.

The Order will come into operation at 0001 hours on Saturdays until 2359 hours on Sundays on consecutive weekends from Saturday, 10 November and will remain in operation until Sunday, 25 November 2007.

# (Temporary Closures) Order 2007

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

- This Order may be cited as "The North Lanarkshire Council (A73 Stirling Road & Lenziemill Road, Cumbernauld) (Temporary Closures) Order 2007" and shall be effective during the period from 0001 hours on Saturdays until 2359 hours on Sundays on consecutive weekends from Saturday, the tenth day of November Two thousand and seven until 2359 hours on Sunday, the twenty-fifth day of November Two thousand and seven.
- 2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on remedial works, antiskid and road markings and emergency vehicles) on the undernoted roads by reason of works being executed on or near those location.

## Closure 1

A73 Stirling Road from the extended line of the west kerb of Auchenkilns Road southeastwards to the start of the northbound off-slip road leading to Blackbog Road.

Alternative routes: Vehicles on the southeast side of the closure wishing to travel to the north-west side of the closure should proceed northwards on the un-named off-slip road to Blackbog Road, eastwards on Blackbog Road, northwards and north-eastwards on B8039 Stirling Road, north-westwards and northwards on Blairlinn Road, north-westwards on B8039 Jane's Brae, westwards on A8011 Glasgow Road, north-westwards on the un-named slip road and un-named link road to Back 'O' Hill Roundabout, eastwards and south-eastwards on B8048 Kirkintilloch Road and south-eastwards on A73 Stirling Road to the northwest side of the closure.

Vehicles on the northwest side of the closure wishing to travel to the A73, south-east of the closure should proceed north-westwards on A73 Stirling Road, north-westwards and westwards on B8048 Kirkintilloch Road, south-eastwards on the un-named link road and un-named slip road from Back 'O' Hill Roundabout to the A8011 Glasgow Road, eastwards on the A8011 Glasgow Road, south-eastwards on B8039 Jane's Brae, southwards and south-eastwards on B8039 Blairlinn Road and south-westwards and southwards on B8039 Stirling Road to the A73.

Vehicles on the southeast side of the closure wishing to travel to Lenziemill Road should proceed northwards on the un-named off-slip road to Blackbog Road, eastwards on Blackbog Road, northwards and north-eastwards on B8039 Stirling Road, north-westwards and northwards on Blairlinn Road to Lenziemill Road.

Vehicles on the northwest side of the closure wishing to travel to Lenziemill Road should proceed north-westwards on A73 Stirling Road, north-westwards and westwards on B8048 Kirkintilloch Road, south-eastwards on the un-named link road and unnamed slip road from Back 'O' Hill Roundabout to the A8011 Glasgow Road eastwards on the A8011 Glasgow Road and south-eastwards on B8039 Jane's Brae to Lenziemill Road.

### Closure 2

Lenziemill Road from its junction with the A73 Stirling Road north-eastwards to the extended line of the south-west kerb of the access to the Greenfaulds Station, Park and Ride.

Alternative routes: Vehicles on the north-east side of the closure wishing to travel to the A73, south east of the closure should proceed north-eastwards on Lenziemill Road, southwards and south-eastwards on B8039 Blairlinn Road and southwestwards and southwards on B8039 Stirling Road to the A73.

Vehicles on the north-east side of the closure wishing to travel to the A73 or A80, northwest of the closure should proceed north-eastwards on Lenziemill Road, northwestwards on B8039 Jane's Brae, westwards on A8011 Glasgow Road, northwestwards on the un-named slip road and un-named link road to Back 'O' Hill Roundabout and eastwards and south-eastwards on B8048 Kirkintilloch Road to the A73 and A80.

Pedestrian access will be permitted.

Both roads will be closed at the same time.
