Sunnyside Road, West Canal Street & Main Street, Coatbridge

(Temporary Traffic Management) Order 2008

On 12 March 2008 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on North Lanarkshire Council's Environmental Improvement Scheme) on the undernoted roads by reason of works being executed on or near those locations.

Closure 1

Sunnyside Road from its junction with the Fountain roundabout at Main Street, South Circular Road, Bank Street and West Canal Street northwards to the extended line of the southern kerb of Baird Street.

Alternative routes: Vehicles on the south side of the closure wishing to travel to the north side of the closure should proceed south-eastwards on A89 South Circular Road, proceed around the roundabout, exiting and proceeding north-westwards then northwards on B804 Dunbeth Road and westwards then south-westwards on Sunnyside Road to the north side of the closure.

Vehicles on the north side of the closure should proceed vice versa.

Closure 2

West Canal Street from its junction with the Fountain roundabout at Main Street, South Circular Road, Bank Street and Sunnyside Road westwards to the line of the extended eastern kerb of Heritage Way.

Alternative routes: Vehicles on the west side of the closure wishing to travel to the east side of the closure should proceed south-westwards on West Canal Street, southwards on Blairhill Street proceed around the roundabout, exiting and proceeding north-eastwards on A89 Bank Street to the east side of the closure.

Vehicles on the east side of the closure should proceed vice versa.

Closure 3

Main Street from its junction with the Fountain roundabout at South Circular Road, Bank Street, West Canal Street and Sunnyside Road eastwards to the extended line of the western kerb of Academy Street.

Alternative routes: Vehicles on the south side of the closure wishing to travel to the north side of the closure should proceed south-eastwards on A89 South Circular Road, proceed around the roundabout, exiting and proceeding north-westwards then northwards on B804 Dunbeth Road, westwards then south-westwards on Sunnyside Road, eastwards on Baird Street and southwards on Academy Street to the west side of the closure.

During the works it will not be possible for vehicles from Whittington Street, or vehicles travelling to the service area at 18-82 Main Street to perform a U-Turn manoeuvre at the "Fountain" roundabout. To overcome this, the following Orders prohibiting the right turn from Whittington Street and to the service area at 18-82 Main Street shall be temporarily revoked for the duration of this Order.

Orders temporarily revoked

Schedule V of The Strathclyde Regional Council (Coatbridge Town Centre) (Traffic Regulation) (amendment) Order 1990 - which prohibits right hand turns from Whittington Street to South Circular Road "only".

The Strathclyde Regional Council (South Circular Road, Coatbridge) (Prohibition of Right Hand Turns) Order 1982 – which prohibits right hand turns from South Circular Road, Coatbridge to southeast of the rear service area of nos 18-82 Main Street.

Pedestrian access will be maintained at all times. However, it may be necessary to switch off the signalised pedestrian crossings from time to time.

The Order will come into operation at 0001 hours and remain in operation until 2359 hours on consecutive Sundays from Sunday, 23 March 2008 until Sunday, 27 April 2008.

(Temporary Traffic Management) Order 2008

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Sunnyside Road, West Canal Street & Main Street, Coatbridge) (Temporary Traffic Management) Order 2008” and shall be effective during the period from 0001 until 2359 hours on consecutive Sundays, from Sunday, the twenty-third day of March, two thousand and eight until Sunday, the twenty-seventh day of April, Two thousand and eight.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on North Lanarkshire Council’s Environmental Improvement Scheme) on the undernoted roads by reason of works being executed on or near those locations.

Closure 1

Sunnyside Road from its junction with the Fountain roundabout at Main Street, South Circular Road, Bank Street and West Canal Street northwards to the extended line of the southern kerb of Baird Street.

Alternative routes: Vehicles on the south side of the closure wishing to travel to the north side of the closure should proceed south-eastwards on A89 South Circular Road, proceed around the roundabout, exiting and proceeding north-westwards then northwards on B804 Dunbeth Road and westwards then south-westwards on Sunnyside Road to the north side of the closure.

Vehicles on the north side of the closure should proceed vice versa.

Closure 2

West Canal Street from its junction with the Fountain roundabout at Main Street, South Circular Road, Bank Street and Sunnyside Road westwards to the line of the extended eastern kerb of Heritage Way.

Alternative routes: Vehicles on the west side of the closure wishing to travel to the east side of the closure should proceed south-westwards on West Canal Street, southwards on Blairhill Street proceed around the roundabout, exiting and proceeding north-eastwards on A89 Bank Street to the east side of the closure.

Vehicles on the east side of the closure should proceed vice versa.

Closure 3

Main Street from its junction with the Fountain roundabout at South Circular Road, Bank Street, West Canal Street and Sunnyside Road eastwards to the extended line of the western kerb of Academy Street.

Alternative routes: Vehicles on the south side of the closure wishing to travel to the north side of the closure should proceed south-eastwards on A89 South Circular Road, proceed around the roundabout, exiting and proceeding north-westwards then northwards on B804 Dunbeth Road, westwards then south-westwards on Sunnyside Road, eastwards on Baird Street and southwards on Academy Street to the west side of the closure.

During the works it will not be possible for vehicles from Whittington Street, or vehicles travelling to the service area at 18-82 Main Street to perform a U-Turn manoeuvre at the "Fountain" roundabout. To overcome this, the following Orders prohibiting the right turn from Whittington Street and to the service area at 18-82 Main Street are temporarily revoked for the duration of this Order.

Orders temporarily revoked

Schedule V of The Strathclyde Regional Council (Coatbridge Town Centre) (Traffic Regulation) (amendment) Order 1990 - which prohibits right hand turns from Whittington Street to South Circular Road "only".

The Strathclyde Regional Council (South Circular Road, Coatbridge) (Prohibition of Right Hand Turns) Order 1982 – which prohibits right hand turns from South Circular Road, Coatbridge to southeast of the rear service area of nos 18-82 Main Street.

Pedestrian access will be maintained at all times. However, it may be necessary to switch off the signalised pedestrian crossings from time to time.
