B8054 Lye Brae, Cumbernauld (South-eastward Carriageway)

(Temporary Closure) Order 2009

On 12 February 2009 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on footbridge refurbishment works) on B8054 Lye Brae, Cumbernauld on the south-eastward carriageway from its junctions with A8011 Wilderness Brae south-eastwards to its junction with the Kildrum South Roundabout by reason of works being executed on or near that location.

Alternative routes: Vehicles travelling south-westwards on A8011 Wilderness Brae wishing to access Kildrum South Roundabout should continue south-westwards to Town Centre East Roundabout, proceed around the Roundabout and return north-eastwards on A8011 Wilderness Brae exiting north-eastwards on the un-named slip road to A8011 Braehead Roundabout, exiting on Kildrum Road and proceeding north-eastwards, south-eastwards then south-westwards on Kildrum Road to the Kildrum South Roundabout.

Vehicles travelling north-eastwards on A8011 Wilderness Brae wishing to access Kildrum South Roundabout should continue north-eastwards on A8011 Wilderness Brae to Old Inns Roundabout, proceed around the Roundabout and return south-westwards on A8011 Wilderness Brae, exiting southwards on the unnamed slip road to Braehead Roundabout, exiting on Kildrum Road and proceeding north-eastwards, south-eastwards then south-westwards on Kildrum Road to the Kildrum South Roundabout.

Vehicles on Braehead Roundabout wishing to access Kildrum South Roundabout should proceed around the Roundabout, exiting on Kildrum Road and proceeding north-eastwards, south-eastwards then south-westwards on Kildrum Road to the Kildrum South Roundabout.

Pedestrian access will be maintained at all times.

Vehicular access will be permitted, where practical, during the closure.

The Order will come into operation at 0001 hours on Monday, 23 February 2009 and will remain in operation until 2359 hours on Friday, 15 May 2009.

(Temporary Closure) Order 2009

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (B804 Lye Brae, Cumbernauld (South-eastward Carriageway)) (Temporary Closure) Order 2009” and shall be effective during the period from 0001 hours on Monday, the twenty-third day of February, two thousand and nine until 2359 hours on Friday, the fifteenth day of May, Two thousand and nine.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on footbridge refurbishment works) on B8054 Lye Brae, Cumbernauld on the south-eastward carriageway from its junctions with A8011 Wilderness Brae south-eastwards to its junction with the Kildrum South Roundabout by reason of works being executed on or near that location.

Alternative routes: Vehicles travelling south-westwards on A8011 Wilderness Brae wishing to access Kildrum South Roundabout should continue south-westwards to Town Centre East Roundabout, proceed around the Roundabout and return north-eastwards on A8011 Wilderness Brae exiting north-eastwards on the un-named slip road to A8011 Braehead Roundabout, exiting on Kildrum Road and proceeding north-eastwards, south-eastwards then south-westwards on Kildrum Road to the Kildrum South Roundabout.

Vehicles travelling north-eastwards on A8011 Wilderness Brae wishing to access Kildrum South Roundabout should continue north-eastwards on A8011 Wilderness Brae to Old Inns Roundabout, proceed around the Roundabout and return south-westwards on A8011 Wilderness Brae, exiting southwards on the unnamed slip road to Braehead Roundabout, exiting on Kildrum Road and proceeding north-eastwards, south-eastwards then south-westwards on Kildrum Road to the Kildrum South Roundabout.

Vehicles on Braehead Roundabout wishing to access Kildrum South Roundabout should proceed around the Roundabout, exiting on Kildrum Road and proceeding north-eastwards, south-eastwards then south-westwards on Kildrum Road to the Kildrum South Roundabout.

Pedestrian access will be maintained at all times.

Vehicular access will be permitted, where practical, during the closure.
