A89 Airdrie Road, Plains

(Temporary Closure) Order 2009

On 26 August 2009 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on the replacement works of A89 Main Street bridge (Barblues Bridge)) on the following roads by reason of works being executed on or near that location.

Location 1

A89 Airdrie Road from a point 330 metres northeast of the extended north east kerbline of Learigg Road north eastwards for a distance of 45 metres or thereby.

Location 2

A89 Airdrie Road from a point 85 metres north east of the extended line of the north east kerbline of Stepends Road north eastwards for a distance of 65 metres or thereby.

Alternative routes: Vehicles on the south west side of the location 1 closure wishing to access the north east side of the location 2 closure should proceed north eastwards on temporary new road 1 (leading from the north west side of the location 1 closure to the north east side of the location 2 closure) to the north east side of the location 2 closure.

Vehicles on the south west side of the location 1 closure wishing to access Stepends Road at the north east side of the location 1 closure should proceed north eastwards and south eastwards on temporary new road 1 and then temporary new road 2 (leading from temporary new road 1 to the south west side of the location 2 closure) and south westwards on A89 Airdrie Road to Stepends Road.

Vehicles on Stepends Road at the north east side of the location 1 closure wishing to access the north east side of the location 2 closure should proceed north eastwards on A89 Airdrie Road and north westwards on temporary new road 2 and north eastwards on temporary new road 1 to the north east side of the location 2 closure.

Vehicles on Stepends Road at the north east side of the location 1 closure wishing to access the south west side of the location 1 closure should proceed north eastwards on A89 Airdrie Road and north westwards on temporary new road 2 and south westwards on temporary new road 1 to the south west side of the location 1 closure.

Vehicles on the north east side of the location 2 closure wishing to access the south west side of the location 1 closure should proceed south westwards on temporary new road 1 to the south west side of the location 1 closure.

Vehicles on the north east side of the location 2 closure wishing to access Stepends Road at the north east side of the location 1 closure should proceed south westwards on temporary new road 1 and south eastwards on temporary new road 2 and south westwards on A89 Airdrie Road to Stepends Road.

The Order will come into operation at 0700 hours on Friday, 4 September 2009 and will remain in operation until 1800 hours on Monday, 31 May 2010.

(Temporary Closure) Order 2009

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as "The North Lanarkshire Council (A89 Airdrie Road, Plains) (Temporary Closure) Order 2009" and shall be effective during the period from 0700 hours on Friday, the fourth day of September, two thousand and nine until 1800 hours on Monday, the thirty-first day of May, Two thousand and ten.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on the replacement works of A89 Main Street bridge (Barblues Bridge)) on the following roads by reason of works being executed on or near that location.

Location 1

A89 Airdrie Road from a point 330 metres northeast of the extended north east kerbline of Learigg Road north eastwards for a distance of 45 metres or thereby.

Location 2

A89 Airdrie Road from a point 85 metres north east of the extended line of the north east kerbline of Stepends Road north eastwards for a distance of 65 metres or thereby.

Alternative routes: Vehicles on the south west side of the location 1 closure wishing to access the north east side of the location 2 closure should proceed north eastwards on temporary new road 1 (leading from the north west side of the location 1 closure to the north east side of the location 2 closure) to the north east side of the location 2 closure.

Vehicles on the south west side of the location 1 closure wishing to access Stepends Road at the north east side of the location 1 closure should proceed north eastwards and south eastwards on temporary new road 1 and then temporary new road 2 (leading from temporary new road 1 to the south west side of the location 2 closure) and south westwards on A89 Airdrie Road to Stepends Road.

Vehicles on Stepends Road at the north east side of the location 1 closure wishing to access the north east side of the location 2 closure should proceed north eastwards on A89 Airdrie Road and north westwards on temporary new road 2 and north eastwards on temporary new road 1 to the north east side of the location 2 closure.

Vehicles on Stepends Road at the north east side of the location 1 closure wishing to access the south west side of the location 1 closure should proceed north eastwards on A89 Airdrie Road and north westwards on temporary new road 2 and south westwards on temporary new road 1 to the south west side of the location 1 closure.

Vehicles on the north east side of the location 2 closure wishing to access the south west side of the location 1 closure should proceed south westwards on temporary new road 1 to the south west side of the location 1 closure.

Vehicles on the north east side of the location 2 closure wishing to access Stepends Road at the north east side of the location 1 closure should proceed south westwards on temporary new road 1 and south eastwards on temporary new road 2 and south westwards on A89 Airdrie Road to Stepends Road.
