

**North Lanarkshire Council**  
**Constarry Road Parking Area, Croy**  
**(Temporary Waiting Restriction) Order 2009**

On 23 September 2009 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to cause or permit any vehicle to wait, for a period of time exceeding 1 hour, or to return to the Parking Area within 3 hours, between 0700 hours until 1800 hours Monday to Friday on Constarry Road Parking Area, Croy by reason of the need to prevent damage to the public road and danger to pedestrians due to footway/verge parking on adjacent roads by making the parking area available for general use throughout the day.

The Order will come into operation at 0700 hours on Monday, 5 October 2009 and will remain in operation until 1800 hours on Friday, 1 April 2011.

**(Temporary Waiting Restriction) Order 2009**

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Constarry Road Parking Area, Croy) (Temporary Waiting Restriction) Order 2009” and shall be effective during the period from 0700 hours on Monday, the fifth day of October, Two thousand and nine until 1800 hours on Friday, the first day of April, Two thousand and eleven.
2. No person shall cause or permit any vehicle to wait, for a period of time exceeding 1 hour, or to return to the Parking Area within 3 hours, between 0700 hours and 1800 hours Monday to Friday in Constarry Road Parking Area, Croy by reason of the need to prevent damage to the public road and danger to pedestrians due to footway/verge parking on adjacent roads by making the parking area available for general use throughout the day
