

**North Lanarkshire Council**  
**A752 Langmuir Road, Bargeddie**  
**(Temporary Closure) Order 2010**

On 20 January 2010 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on carriageway resurfacing works) on A752 Langmuir Road, Bargeddie from its junction with A89 Coatbridge Road south eastwards to the extended line of the northern kerb of Langmuir Way by reason of works being executed on or near that location.

*Alternative routes: Vehicles on the north west side of the closure wishing to access the south east side of the closure should proceed eastwards on A89 Coatbridge Road, eastwards, south eastwards and north eastwards on A89 Glasgow Road, north eastwards on A89 Bank Street and south eastwards on A89 South Circular Road, southwards on A725 Coatbank Street, A725 Whifflet Street and A725 North Road to Shawhead Interchange, north- westwards on A8 Glasgow & Edinburgh Road to Drumpark Interchange and north westwards on A752 Aitkenhead Road and A752 Langmuir Road to the south east side of the closure.*

*Vehicles on the south east side of the closure wishing to access the north west side of the closure should proceed south eastwards on A752 Langmuir Road and A752 Aitkenhead Road to Drumpark Interchange, south westwards on A8 Glasgow & Edinburgh Road to Shawhead Interchange, northwards on A725 North Road, A725 Whifflet Street and A725 Coatbank Street, north westwards on A89 South Circular Road, south westwards on A89 Bank Street, south westwards, north westwards and westwards on A89 Glasgow Road and westwards on A89 Coatbridge Road to the north west side of the closure.*

*Diversion routes will also be signposted.*

Pedestrian access will be maintained at all times during the closure.

The Order, which will only be effective when displayed by signs, will come into operation at 0001 hours on Saturday, 6 February 2010 and will remain in operation until 2359 hours on Sunday, 28 March 2010.

**(Temporary Closure) Order 2010**

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as "The North Lanarkshire Council (A752 Langmuir Road, Bargeddie) (Temporary Closure) Order 2010" and shall be effective only when displayed by signs during the period from 0001 hours on Saturday, the sixth day of February, two thousand and ten until 2359 hours on Sunday, the twenty-eighth day of March, Two thousand and ten.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on carriageway resurfacing works) on A752 Langmuir Road, Bargeddie from its junction with A89 Coatbridge Road south eastwards to the extended line of the northern kerb of Langmuir Way by reason of works being executed on or near that location.

*Alternative routes: Vehicles on the north west side of the closure wishing to access the south east side of the closure should proceed eastwards on A89 Coatbridge Road, eastwards, south eastwards and north eastwards on A89 Glasgow Road, north eastwards on A89 Bank Street and south eastwards on A89 South Circular Road, southwards on A725 Coatbank Street, A725 Whifflet Street and A725 North Road to Shawhead Interchange, north- westwards on A8 Glasgow & Edinburgh Road to Drumpark Interchange and north westwards on A752 Aitkenhead Road and A752 Langmuir Road to the south east side of the closure.*

*Vehicles on the south east side of the closure wishing to access the north west side of the closure should proceed south eastwards on A752 Langmuir Road and A752 Aitkenhead Road to Drumpark Interchange, south westwards on A8 Glasgow & Edinburgh Road to Shawhead Interchange, northwards on A725 North Road, A725 Whifflet Street and A725 Coatbank Street, north westwards on A89 South Circular Road, south westwards on A89 Bank Street, south westwards, north westwards and westwards on A89 Glasgow Road and westwards on A89 Coatbridge Road to the north west side of the closure.*

*Diversion routes will also be signposted.*

Pedestrian access will be maintained at all times during the closure.
