

North Lanarkshire Council
Shottskirk Road, Shotts
(Temporary Road Closure) Order 2010

On 14 April 2010 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on underground grouting works) on Shottskirk Road, Shotts from a point 10 metres south of its junction with Hillhouseridge Road, Shotts southwards for a distance of 50 metres or thereby by reason of works being executed on or near that location.

Alternative routes: Vehicles on the north side of the closure wishing to access the south side of the closure should proceed northwards on Shottskirk Road, eastwards on Hillhouseridge Road, north eastwards, southwards and south westwards on Dyfrig Street, westwards on Station Road then north eastwards on Shottskirk Road to the south side of the closure.

Vehicles on the south side of the closure wishing to access the north side of the closure should proceed vice versa.

Vehicular access to adjacent premises will be maintained, where possible, by arrangement with the contractor during the closure.

Pedestrian access will be maintained at all times where applicable.

Appropriate signage will be in place advising drivers of the restrictions during the closure. The closure will only be valid when appropriate signing is in place.

The Order will come into operation at 0900 hours on Wednesday, 28 April 2010 and will remain in operation until 2359 hours on Friday, 23 July 2010.

(Temporary Road Closure) Order 2010

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Shottskirk Road, Shotts) (Temporary Road Closure) Order 2010” and shall be effective during the period from 0900 hours on Wednesday, the twenty eighth day of April, Two thousand and ten until 2359 hours on Friday, the twenty third day of July, Two thousand and ten.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on underground grouting works) on Shottskirk Road, Shotts from a point 10 metres south of its junction with Hillouseridge Road, Shotts southwards for a distance of 50 metres or thereby by reason of works being executed on or near that location.

Alternative routes: Vehicles on the north side of the closure wishing to access the south side of the closure should proceed northwards on Shottskirk Road, eastwards on Hillouseridge Road, north eastwards, southwards and south westwards on Dyfrig Street, westwards on Station Road then north eastwards on Shottskirk Road to the south side of the closure.

Vehicles on the south side of the closure wishing to access the north side of the closure should proceed vice versa.

Vehicular access to adjacent premises will be maintained, where possible, by arrangement with the contractor during the closure.

Pedestrian access will be maintained at all times where applicable.

Appropriate signage will be in place advising drivers of the restrictions during the closure. The closure will only be valid when appropriate signing is in place.
