Unnamed Slip Road onto A8011 North Bound, Cumbernauld

(Temporary Road Closure) Order 2010

On 26 May 2010 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on works on Braehead roundabout) on the unnamed slip road onto the north east bound carriageway of the A8011 from its junction with the unnamed slip road from the north west bound carriageway of Lye Brae to its junction with A8011 by reason of works being executed on or near that location.

Alternative route: Vehicles travelling north westwards on Lye Brae wishing to travel north eastwards on the A8011 should proceed north eastwards on the other unnamed slip road to Braehead roundabout, proceed around the roundabout and exit and proceed north eastwards on the unnamed slip road to the north east bound carriageway of the A8011.

The Order will come into operation at 0001 hours on Monday, 7 June 2010 and will remain in operation until 1700 hours on Tuesday, 30 November 2010.

Unnamed Slip Road onto A8011 North Bound, Cumbernauld

(Temporary Road Closure) Order 2010

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984 (as amended by Schedule 1 of the Road Traffic (Temporary Restriction) Act 1991), and of all other enabling powers, hereby make the following Order:-

- (1) This Order may be cited as "The North Lanarkshire Council (Unnamed Slip Road onto A8011 North Bound, Cumbernauld) (Temporary Road Closure) Order 2010" and be effective during the period from 0001 hours on Monday, the seventh day of June, Two thousand and ten until 1700 hours on Tuesday, the thirtieth day of November, Two thousand and ten.
- (2) No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on works on Braehead roundabout) on the unnamed slip road onto the north east bound carriageway of the A8011 from its junction with the unnamed slip road from the north west bound carriageway of Lye Brae to its junction with A8011 by reason of works being executed on or near that location.

Alternative route: Vehicles travelling north westwards on Lye Brae wishing to travel north eastwards on the A8011 should proceed north eastwards on the other unnamed slip road to Braehead roundabout, proceed around the roundabout and exit and proceed north eastwards on the unnamed slip road to the north east bound carriageway of the A8011.
