**(Temporary Traffic Management) Order 2010**

On 23 June 2010 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, made the above-named Order to be observed by vehicles on the following roads on Saturday, 10 July 2010.

**Roads to be closed to all vehicles**

A71 Overtown Road, Wishaw from its junction with the A721 Wishaw Road to its junction with the A73 Main Street, Newmains.

*Alternative Routes: Vehicles on the north east side of the closure wishing to access the south west side of the closure should proceed south eastwards on the A73 Main Street and westwards on the A721 Wishaw Road to the south west side of the closure.*

*Vehicles on the south west side of the closure wishing to access the north east side of the closure should proceed vice versa.*

**“No Waiting” Restrictions**

A721 Wishaw Road/Stewarton Street

*From the extended line of the north western kerb of Overtown Road to a point 50 metres north west of the extended line of the north western kerb of McAlpine Street.*

Marshall Street

*Over its entire length*

Alexander Street

*Over its entire length*

Dundyvan Street

*From its junction with Alexander Street, north eastwards for a distance of 125 metres or thereby.*

Station Road

*Over the entire length, on the south west side of the road only.*

Netherton Street

*From its junction with A721 Glasgow Road, south westwards for a distance of 565 metres or thereby.*

Appropriate signing will be in place advising drivers of the restrictions.

Vehicular access to adjacent premises will be maintained during the closure.

Pedestrian access will be maintained at all times, where applicable.

The Order will come into operation at 0001 hours on Saturday, 10 July 2010 and will remain in operation until 2359 hours on Saturday, 10 July 2010.

#### **(Temporary Traffic Management) Order 2010**

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Various Streets, Wishaw) (Temporary Traffic Management) Order 2010” and shall be effective during the period from 0001 hours on Saturday, the tenth day of July, Two thousand and ten until 2359 hours on Saturday, the tenth day of July, Two thousand and ten.

#### **Roads to be closed to all vehicles**

A71 Overtown Road, Wishaw from its junction with the A721 Wishaw Road to its junction with the A73 Main Street, Newmains.

*Alternative Routes: Vehicles on the north east side of the closure wishing to access the south west side of the closure should proceed south eastwards on the A73 Main Street and westwards on the A721 Wishaw Road to the south west side of the closure.*

*Vehicles on the south west side of the closure wishing to access the north east side of the closure should proceed vice versa.*

#### **“No Waiting” Restrictions**

A721 Wishaw Road/Stewarton Street

*From the extended line of the north western kerb of Overtown Road to a point 50 metres north west of the extended line of the north western kerb of McAlpine Street.*

Marshall Street

*Over its entire length*

Alexander Street

*Over its entire length*

Dundyvan Street

*From its junction with Alexander Street, north eastwards for a distance of 125 metres or thereby.*

Station Road

*Over the entire length, on the south west side of the road only.*

Netherton Street

*From its junction with A721 Glasgow Road, south westwards for a distance of 565 metres or thereby.*

Appropriate signing will be in place advising drivers of the restrictions.

Vehicular access to adjacent premises will be maintained during the closure.

Pedestrian access will be maintained at all times, where applicable.
