(Temporary Road Closure) Order 2011

On 12 January 2011 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on installation of ducting and power cable) on Callon Street, Airdrie from its junction with A89 Weaver Road to its junction with B802 Broomknoll Street by reason of works being executed on or near that location.

Alternative routes: There are no alternative routes.

Pedestrian access will be maintained at all times where applicable.

The Order, which will be effective only on Sundays between 0001 hours and 2359 hours and only when displayed by signs, will come into operation at 0001 hours on Sunday, 30 January 2011 and will remain in operation until 2359 hours on Sunday, 13 February 2011.

(Temporary Road Closure) Order 2011

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as "The North Lanarkshire Council (Callon Street - Airdrie) (Temporary Road Closure) Order 2011", shall be effective only on Sundays between 0001 hours and 2359 hours and only when displayed by signs, and will come into operation at 0001 hours on Sunday, the thirtieth day of January, Two thousand and eleven and shall remain in operation until 2359 hours on Sunday, the thirteenth day of February, Two thousand and eleven.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on installation of ducting and power cable) on Callon Street, Airdrie from its junction with A89 Weaver Road to its junction with B802 Broomknoll Street by reason of works being executed on or near that location.

Alternative routes: There are no alternative routes.

Pedestrian access will be maintained at all times where applicable.
