Tollbrae Avenue, Airdrie
(Temporary Road Closure) Order 2011

On 14 December 2011 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on footway resurfacing and carriageway patching works) on Tollbrae Avenue, Airdrie from its junction with Old Union Street to its junction with Broomfield Street by reason of works being executed on or near that location.

Alternative routes: Vehicles on the west side of the closure wishing to access the north side of the closure should proceed north westwards on Old Union Street and north eastwards on Broomfield Street to the north side of the closure.

Vehicles on the north side of the closure wishing to access the west side of the closure should proceed vice versa.

Pedestrian access will be maintained where applicable.

The Order will come into operation at 0001 hours on Monday, 9 January 2012 and will remain in operation until 2359 hours on Friday, 20 January 2012.

(Temporary Road Closure) Order 2011

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as "The North Lanarkshire Council (Tollbrae Avenue, Airdrie) (Temporary Road Closure) Order 2011" and shall be effective during the period from 0001 hours on Monday, the ninth day of January, Two thousand and twelve until 2359 hours on Friday, the twentieth day of January, Two thousand and eleven.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on footway resurfacing and carriageway patching works) on Tollbrae Avenue, Airdrie from its junction with Old Union Street to its junction with Broomfield Street by reason of works being executed on or near that location.

Alternative routes: Vehicles on the west side of the closure wishing to access the north side of the closure should proceed north westwards on Old Union Street and north eastwards on Broomfield Street to the north side of the closure.

Vehicles on the north side of the closure wishing to access the west side of the closure should proceed vice versa.

Pedestrian access will be maintained where applicable.
