A8011 Central Way, Cumbernauld
(Temporary Road Closure) Order No 2 2011

On 14 December 2011 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on the demolition of a footbridge and associated works) on A8011 Central Way, Cumbernauld from its junction with the Town Centre East Roundabout to its junction with the Town Centre West Roundabout by reason of works being executed on or near that location.

Alternative routes: Vehicles on the north east side of the closure wishing to access the south east side of the closure should proceed south eastwards on Yule Way, south westwards on North Carbrain Road and north westwards on McIntosh Way to the south west side of the closure.

Vehicles on the south west side of the closure wishing to access the north east side of the closure should proceed vice versa.

Pedestrian access will be maintained at all times.

The Order will come into operation at 0001 hours on Sunday, 15 January 2012 and will remain in operation until 2359 hours on Thursday, 31 May 2012.

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (A8011 Central Way, Cumbernauld) (Temporary Road Closure) Order No 2 2011” and shall be effective during the period from 0001 hours on Sunday, the fifteenth day of January, Two thousand and twelve until 2359 hours on Thursday, the thirty first day of May, Two thousand and twelve.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on the demolition of a footbridge and associated works) by reason of works being executed on or near that location.

Alternative routes: Vehicles on the north east side of the closure wishing to access the south east side of the closure should proceed south eastwards on Yule Way, south westwards on North Carbrain Road and north westwards on McIntosh Way to the south west side of the closure.

Vehicles on the south west side of the closure wishing to access the north east side of the closure should proceed vice versa.

Pedestrian access will be maintained at all times.
