(Temporary Road Closure) Order 2012

On 14 May 2012 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles connected with Bellshill Community Council's Annual Street Fair) on Main Street, Bellshill from the extended line of the western kerb of Emma Jay Road, westwards to the extended line of the eastern kerb of Motherwell Road, by reason of the Annual Street Fair.

Alternative routes: Vehicles on the east side of the closure wishing to access the west side of the closure should proceed eastwards on Main Street, north westwards on A775 Campbell Street, south westwards on B7070 North Road and Hamilton Road, eastwards on Neilson Street and northwards on A721 Motherwell Road to the west side of the closure.

Pedestrian access will be maintained at all times.

The Order will come into operation at 1800 hours on Friday, 1 June 2012 and will remain in operation until 0500 hours on Tuesday, 5 June 2012.

(Temporary Road Closure) Order 2012

The North Lanarkshire Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Main Street, Bellshill) (Temporary Road Closure) Order 2012” and shall be effective during the period from 1800 hours on Friday, the first day of June, Two thousand and twelve until 0500 hours on Tuesday, the fifth day of June, Two thousand and twelve.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles connected with Bellshill Community Council’s Annual Street Fair) on Main Street, Bellshill from the extended line of the western kerb of Emma Jay Road, westwards to the extended line of the eastern kerb of Motherwell Road, by reason of the Annual Street Fair.

Alternative routes: Vehicles on the east side of the closure wishing to access the west side of the closure should proceed eastwards on Main Street, north westwards on A775 Campbell Street, south westwards on B7070 North Road and Hamilton Road, eastwards on Neilson Street and northwards on A721 Motherwell Road to the west side of the closure.

Pedestrian access will be maintained at all times.
