(Temporary Road Closure) Order 2012

On 10 September 2012 the North Lanarkshire Council made the above-named Order under Section 62 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991 and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles being used in connection with the filming of a BBC Drama/Documentary) on Myvot Road, Coatbridge from the extended line of the western kerb of B802 Condorrat Road, south westwards to the extended line of the eastern kerb of Wester Myvot Road.

Alternative routes: Vehicles on the south west side of the closure wishing to access the north east side of the closure should proceed eastwards on Wester Myvot Road and northwards on B802 Condorrat Road.

Vehicles on the north east side of the closure wishing to access the south west side of the closure should proceed vice versa.

Pedestrian access is not available, pedestrians to follow alternative route as stated above.

The Order, which will be operational only when displayed by signs, will come into operation on Wednesday, 26 September 2012, between the hours of 0830 hours and 1930 hours and on Thursday, 27 September 2012 between the hours of 0800 hours and 1900 hours.

(Temporary Road Closure) Order 2012

The North Lanarkshire Council in exercise of the powers conferred on them by Section 62 of the Road Traffic Regulation Act 1984, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Myvot Road, Coatbridge) (Temporary Closure) Order 2012” and shall be effective, only when displayed by signs, during the period from 0830 hours and 1930 hours on Wednesday, the twenty-sixth day of September, two thousand and twelve until 0800 hours and 1900 hours on Thursday, the twenty-seventh day of September, Two thousand and twelve.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles being used in connection with the filming of a BBC Drama/Documentary) on Myvot Road, Coatbridge from the extended line of the western kerb of B802 Condorrat Road, south westwards to the extended line of the eastern kerb of Wester Myvot Road.

Alternative routes: Vehicles on the south west side of the closure wishing to access the north east side of the closure should proceed eastwards on Wester Myvot Road and northwards on B802 Condorrat Road.

Vehicles on the north east side of the closure wishing to access the south west side of the closure should proceed vice versa.

Pedestrian access is not available, pedestrians to follow alternative route as stated above.
