Hillcrest Road and Meadowside Road, Queenzieburn, Kilsyth

(Temporary Road Closure) Order 2013

On 25 February 2013 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on resurfacing works) on the undernoted roads, by reason of works being executed on or near those locations.

Location 1

Hillcrest Road, Queenzieburn, Kilsyth from a point 75 metres, or thereby north east of its junction with Meadowside Road to its termination.

Location 2

Meadowside Road, Queenzieburn, Kilsyth from its junction with Hillcrest Road, south eastwards for a distance of 40 metres or thereby.

Alternative routes: Vehicles on the south west side of the closure wishing to access the south east side of the closure should proceed south westwards on Hillcrest Road and north eastwards and north westwards on Meadowside Road to the south east side of the closure.

Vehicles on the south east side of the closure wishing to access the south west side of the closure should proceed vice versa.

Vehicular and pedestrian access will be maintained, where practicable, during the closure.

The Order, which will only be valid when signage is in place, will come into operation at 0800 hours on Monday, 18 March 2013 and will remain in operation until 1800 hours on Friday, 29 March 2013.

(Temporary Road Closure) Order 2013

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Hillcrest Road and Meadowside Road, Queenzieburn, Kilsyth) (Temporary Road Closure) Order 2013” and shall be effective during the period from 0800 hours on Monday, the eighteenth day of March, Two thousand and thirteen until 1800 hours on Friday, the twenty ninth day of March, Two thousand and thirteen.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on resurfacing works) on the undernoted roads, by reason of works being executed on or near those locations.

Location 1

Hillcrest Road, Queenzieburn, Kilsyth from a point 75 metres or thereby, north east of its junction with Meadowside Road to its termination.

Location 2

Meadowside Road, Queenzieburn, Kilsyth from its junction with Hillcrest Road, south eastwards for a distance of 40 metres or thereby.

Alternative routes: Vehicles on the south west side of the closure wishing to access the south east side of the closure should proceed south westwards on Hillcrest Road and north eastwards and north westwards on Meadowside Road to the south east side of the closure.

Vehicles on the south east side of the closure wishing to access the south west side of the closure should proceed vice versa.

Vehicular and pedestrian access will be maintained, where practicable, during the closure.
