

North Lanarkshire Council
Muirhouse Avenue, Motherwell
(Temporary Road Closure) Order 2013

On 26 August 2013 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on Scottish Power replacement supply pillar works) on Muirhouse Avenue, Motherwell from its junction with Shields Road, north eastwards for a distance of 30 metres or thereby by reason of works being executed on or near that location.

Alternative routes: Vehicles on the north east side of the closure wishing to access Shields Road should proceed north eastwards, south eastwards then south westwards on Muirhouse Avenue to Shields Road.

Vehicles on Shields Road on the south west side of the closure wishing to access Muirhouse Avenue should proceed vice versa.

Pedestrian access will be maintained at all times.

The Order will come into operation at 0001 hours on Monday, 9 September 2013 and will remain in operation until 2359 hours on Sunday, 29 September 2013.

(Temporary Road Closure) Order 2013

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Muirhouse Avenue, Motherwell) (Temporary Road Closure) Order 2013” and shall be effective during the period from 0001 hours on Monday, the ninth day of September, Two thousand and thirteen until 2359 hours on Sunday, the twenty ninth day of September, Two thousand and thirteen.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on Scottish Power replacement supply pillar works) on Muirhouse Avenue, Motherwell from its junction with Shields Road, north eastwards for a distance of 30 metres or thereby by reason of works being executed on or near that location.

Alternative routes: Vehicles on the north east side of the closure wishing to access Shields Road should proceed north eastwards, south eastwards then south westwards on Muirhouse Avenue to Shields Road.

Vehicles on Shields Road on the south west side of the closure wishing to access Muirhouse Avenue should proceed vice versa.

Pedestrian access will be maintained at all times.
