Unnamed Link Road between B8048 and A8011, Cumbernauld

(Temporary Road Closure) Order 2014

On 16 June 2014 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on barrier repair and drainage works) on the Unnamed Link Road from its junction with the Back O'Hill roundabout to its junction with the A8011, by reason of works being executed on or near that location.

Alternative routes: Vehicles on the north side of the closure wishing to join the A8011 Glasgow Road should proceed eastwards on B8048 Kirkintilloch Road, south eastwards, southwards and south eastwards on the A73, north eastwards on Lenziemill Road and north westwards on B8039 Janes Brae and the on slip road to the A8011 Glasgow Road.

The Order will come into operation at 0001 hours on Monday, 30 June 2014 and will remain in operation until 2359 hours on Monday, 14 July 2014.

(Temporary Road Closure) Order 2014

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Unnamed Link Road between B8048 and A8011, Cumbernauld) (Temporary Road Closure) Order 2014” and shall be effective during the period from 0001 hours on Monday, the thirtieth day of June, Two thousand and fourteen until 2359 hours on Monday, the fourteenth day of July, Two thousand and fourteen.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on barrier repair and drainage works) on the Unnamed Link Road from its junction with the Back O’Hill roundabout to its junction with the A8011, by reason of works being executed on or near that location.

Alternative routes: Vehicles on the north side of the closure wishing to join the A8011 Glasgow Road should proceed eastwards on B8048 Kirkintilloch Road, south eastwards, southwards and south eastwards on the A73, north eastwards on Lenziemill Road and north westwards on B8039 Janes Brae and the on slip road to the A8011 Glasgow Road.
