## **Coursington Road, Motherwell**

# (Temporary Road Closure) Order 2014

On 21 July 2014 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on town centre improvement works) on Coursington Road, Motherwell from a point 50 metres or thereby north east of its junction with Park Street, north eastwards to a point 75 metres or thereby, south west its junction with Dalziel Street, a distance of 92 metres or thereby, by reason of works being executed on or near that location.

Alternative routes: Vehicles on the south west side of the closure wishing to access the north east side of the closure should proceed south westwards on Coursington Road, south eastwards on Park Street, north eastwards on Albert Street, north westwards on Dalziel Street then south westwards on Coursington Road to the north east side of the closure.

Vehicles on the north east side of the closure wishing to access the south west side of the closure should proceed north eastwards on Coursington Road, north westwards on Dalziel Street, south westwards on Scott Street, south eastwards on Park Street and north eastwards on Coursington Road to the south west side of the closure.

Pedestrian access will be maintained at all times.

The Order, which will be operational only when displayed by signs, will come into operation at 0001 hours on Monday, 4 August 2014 and will remain in operation until 2359 hours on Sunday, 31 August 2014.

## (Temporary Road Closure) Order 2014

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

- 1. This Order may be cited as "The North Lanarkshire Council (Coursington Road, Motherwell) (Temporary Road Closure) Order 2014" and shall be effective during the period from 0001 hours on Monday, the fourth day of August, Two thousand and fourteen until 2359 hours on Sunday, the thirty-first day of August, Two thousand and fourteen.
- 2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of vehicles engaged on town centre improvement works) on Coursington Road, Motherwell from a point 50 metres or thereby north east of its junction with Park Street, north eastwards to a point 75 metres or thereby, south west its junction with Dalziel Street, a distance of 92 metres or thereby, by reason of works being executed on or near that location.

Alternative routes: Vehicles on the south west side of the closure wishing to access the north east side of the closure should proceed south westwards on Coursington Road, south eastwards on Park Street, north eastwards on Albert Street, north westwards on Dalziel Street then south westwards on Coursington Road to the north east side of the closure.
