(Temporary Prohibition of Right Turn) Order 2014

On 28 July 2014 the North Lanarkshire Council made the above-named Order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and in exercise of all other enabling powers, which makes it unlawful for any person to undertake a right hand turn manoeuvre (with the exception of vehicles engaged on street lighting works) on the undernoted locations by reason of works being executed on or near those locations.

Location 1

Travelling north westwards on Windmillhill Street into Delburn Street, Motherwell.

Location 2

Travelling south westwards on Delburn Street into Windmillhill Street, Motherwell.

Alternative routes: Vehicles travelling north westwards on Windmillhill Street wishing to turn right onto Delburn Street should continue north westwards on Windmillhill Street, proceed around the roundabout and take the third exit travelling south eastwards on Windmillhill Street to Delburn Street.

Vehicles travelling south westwards on Delburn Street wishing to turn right onto Windmillhill Street should alternatively turn left and proceed south eastwards and eastwards on Windmillhill Street, proceed around the roundabout and take the fourth exit onto Windmillhill Street to the end of the diversion.

The Order will come into operation at 0001 hours on Saturday, 16 August 2014 and will remain in operation until 2359 hours on Sunday, 8 October 2014.

(Temporary Prohibition of Right Turn) Order 2014

The North Lanarkshire Council, in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991, and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as “The North Lanarkshire Council (Windmillhill Street, Motherwell) (Temporary Prohibition of Right Turn) Order 2014” and shall be effective during the period from 0001 hours on Saturday, the sixteenth day of August, Two thousand and fourteen until 2359 hours on Sunday, the eighth day of October, Two thousand and fourteen.
2. No person shall undertake a right hand turn manoeuvre (with the exception of vehicles engaged on street lighting works) on the undernoted locations by reason of works being executed on or near those locations.

Location 1

Travelling north westwards on Windmillhill Street into Delburn Street, Motherwell.

Location 2

Travelling south westwards on Delburn Street into Windmillhill Street, Motherwell.

Alternative routes: Vehicles travelling north westwards on Windmillhill Street wishing to turn right onto Delburn Street should continue north westwards on Windmillhill Street, proceed around the roundabout and take the third exit travelling south eastwards on Windmillhill Street to Delburn Street.

Vehicles travelling south westwards on Delburn Street wishing to turn right onto Windmillhill Street should alternatively turn left and proceed south eastwards and eastwards on Windmillhill Street, proceed around the roundabout and take the fourth exit onto Windmillhill Street to the end of the diversion.
