PRESENTATION - SCOTTISH BOWEL SCREENING PROGRAMME

6. The Convener introduced Sandra MacInnes, Service Development Manager (Public Health), Bellshill Locality, NHS Lanarkshire, who gave a presentation on the Scottish Bowel Screening Programme (1) advising that bowel cancer was the third most common cancer in men and women; (2) indicating that screening would commence in Lanarkshire in August 2009; (3) outlining the procedure for the use of the test kit which would be sent to men and women aged between 50 and 74 years, and (4) emphasising the importance of those people within the appropriate age group participating in the screening programme and responded to questions thereon, during which it was agreed that further information would be provided on (a) whether information on the test kits was available in Gaelic; (b) what the survival rates were for bowel cancer, and (c) the action being taken where this type of cancer was hereditary.

Thereafter, the Convener thanked Sandra MacInnes for her informative and interesting presentation.

Decided: that it be recommended to the Area Committee

7. There was submitted a report dated July 2009 by Tom Bryce, General Manager, NHS Lanarkshire (1) outlining various initiatives that had taken place within the Bellshill Locality; (2) giving details of the current position regarding the Influenza H1N1 Pandemic, including proposals for a mass vaccination programme which was being considered by the Scottish Government, and (3) setting out details of the 48 hour access requirements for doctors, as requested at a previous meeting, together with details of exclusions from these requirements.

JOINT COMMUNITY SAFETY REPORT

8. There was submitted a joint report (docketed as relative to the Minute of the meeting of Bellshill and District Area Committee held on 13 August 2009) dated 13 August 2009 by Housing and Social Work Services, Strathclyde Police and Strathclyde Fire and Rescue (1) advising of initiatives and measures taken to minimise the levels of crime within the Bellshill and District area, and (2) providing statistical information in respect of the three partners.

The Partnership then heard Alison Clarke, Housing Area Manager and Angus McPhail, Strathclyde Police, in supplement to the report and in response to Members' questions, when it was proposed (a) that a report be submitted to the next meeting of the Local Area Partnership on the current position regarding the provision of redeployable CCTV cameras, and (b) that, as part of the Local Development Programme, consideration be given to environmental works being undertaken to overgrown areas of Hattonrigg Park.

Pauline Nicholas, Senior Local Regeneration Manager, then (1) outlined the key points of the report; (2) advised that a report on a suggested programme for 2010/2011 would be submitted to the next meeting and requested that any further projects for inclusion in the Local Development Programme be submitted within one month, and (3) responded to Members' questions, during which it was proposed that the following projects be considered for inclusion within the Local Development Programme: - (a)

the provision of parking bays on Orbiston Drive, Noble Road and Hattonrigg Road; (b) environmental improvements to the housing estate at Birkenshaw, and (c) further works at Viewpark Glen

Decided: that it be recommended to the Area Committee

- (1) that the progress in delivering the projects within the Local Development Programme for 2008/2009, as detailed in Appendix 1 to the report, and 2009/2010, as detailed in Appendix 2 to the report, be noted and details of further progress submitted to future meetings of the Bellshill and District Local Area Partnership;

BELLSHILL TOWN CENTRE ACTION PLAN UPDATE

10. With reference to paragraph 2 of the Minute of the meeting of the Local Area Partnership held on 20 May 2009, there was submitted a report dated 22 July 2009 by the Head of Planning and Development (1) updating the Partnership on the progress made in relation to the Bellshill Town Centre Action Plan, including (a) the completion of Phases 1, 2 and 4 of the project; (b) various delays resulting from the Annual Street Fayre, a major fire on Main Street and the introduction of a temporary Traffic Management System to facilitate the construction of the roundabout on North Road, and (c) the closure of Main Street at the end of the Phase 3 works to allow for the resurfacing of the carriageway, and (2) advising that a bid for funding had been submitted to the Scottish Government's Town Centre Regeneration Fund in respect of the acquisition of the gap site at 278-286 Main Street, which, if successful, would enable the pedestrian route to the Tesco Store to be maintained and enhanced.

Lorna Bowden then outlined the contents of the report and indicated that steps were being taken (1) to minimise delays due to the works in relation to the new roundabout on North Road, and (2) to ensure that the closure to Main Street did not occur during the Christmas period and Lorna, Bill Hazel and Graham MacKay responded to Members' questions.

There then followed a full discussion, when various matters were considered, including (1) the lack of progress in relation to the town centre works; (2) the desire that the next phase of town centre works be kept to a tighter schedule; (3) concerns about the diversion of traffic to facilitate the works to the North Road roundabout, and (4) traffic problems on the roadway leading from Motherwell Road to Crossgates.

Decided: that it be recommended to the Area Committee

- (1) that consideration be given to the provision of double white lines in the middle of Crossgates to prevent overtaking;
- that details of the diversions to be implemented as part of the road closures for the construction of the roundabout on North Road be submitted to the next meeting of the Local Area Partnership;
