RESHAPING CARE FOR OLDER PEOPLE: PROGRESS REPORT

2. There was submitted a report (docketed as relative to the Minute of the meeting of the Bellshill and District Area Committee held on 18 April 2013) dated 18 April 2013 by the Executive Director of Housing and Social Work Services (1) setting out the background to the Scottish Government's policy on Reshaping Care for Older People, which was aimed at supporting an increasing proportion of older people at home, in keeping with their wishes; (2) summarising the progress made, and (3) detailing the impact for the Bellshill Locality.

The Convener then introduced Joe McElholm, Manager Older Adults Services, who was in attendance in relation to the report and who was heard in supplement to the report and in response to Members' questions.

With reference to paragraph 9 of the Minute of the meeting of the Local Area Partnership held on 17 January 2013, there was submitted a report (docketed as relative to the Minute of the meeting of the Bellshill and District Area Committee held on 18 April 2013) dated 18 April 2013 by the Executive Director of Environmental Services (1) providing information in relation to the priority area, identified within the Bellshill Locality as Ward 15 – Mossend and Holytown; (2) setting out, within Appendix 1 to the report, (a) information and actions considered by the Local Community Safety Sub-Group for the period from 1 December 2012 to 28 February 2013, including a “hot spot” map which highlighted crime and anti-social behaviour issues within the priority area; (b) statistical analysis of incidents in the area; (c) the Partner Action Plan for the area which provided a summary of agreed actions to address some of the issues identified, and (d) statistical information in relation to the two remaining wards within the Bellshill and District Locality, and (3) detailing the action taken to promote positive outcomes within the Locality.

The Local Area Partnership then heard Inspector Stewart Hurry, Police Scotland; Alison Clarke, Bellshill Area Housing Manager, North Lanarkshire Council and Group Commander Billy Sim, Scottish Fire and Rescue Service, in supplement to the report and in response to Members' questions.

(1) SCOTTISH POLICE SERVICE - NORTH LANARKSHIRE LOCAL PLAN 2013/2014

8. With reference to paragraph 15 of the Minute of the meeting of the Policy and Resources Committee held on 14 March 2013, when that Committee, having considered a report (docketed as relative to the meeting of that Committee) dated 14 March 2013 by the Chief Executive regarding the Scottish Police Service – North Lanarkshire Local Plan 2013/2014, agreed (1) that the Scottish Police Service North Lanarkshire Local Plan 2013/2014 be approved; (2) that the Police Plan be referred to the Local Area Partnerships and Area Committees, and (3) that the Local Police Commander be requested to provide a progress report in six months time, the Local Area Partnership considered the report.

Inspector Stewart Hurry, Police Scotland, was then heard in supplement to the report when he indicated that the local policing arrangements would remain the same and that the Local Plan would assist in the continuation of the successful partnership working in the Bellshill area.

With reference to paragraph 16 of the Minute of the meeting of the Policy and Resources Committee held on 14 March 2013, when that Committee having considered a report (docketed as relative to the Minute of the meeting of that Committee) dated 14 March 2013 by the Chief Executive regarding the Scottish Fire and Rescue Service North Lanarkshire Local Plan 2013/2014, agreed (1) that the Scottish Fire and Rescue Service North Lanarkshire Local Plan 2013/2014 be approved; (2) that the Fire and Rescue Plan be referred to the Local Area Partnerships and Area Committees, and (3) that the Local Senior Officer, Scottish Fire and Rescue Service, be requested to provide a progress report in six months time, the Local Area Partnership considered the report.

Group Commander Billy Sim, Scottish Fire and Rescue Service, was then heard in supplement to the report when he indicated that the Local Plan had the same objectives as previously and that the Fire and Rescue Plan for 2014/15 would be prepared in October 2013.

BELLSHILL TOWN CENTRE ACTION PLAN – UPDATE

11. With reference to paragraph 11 of the Minute of the meeting of the Local Area Partnership held on 17 January 2013, there was submitted a report (docketed as relative to the Minute of the meeting of the Bellshill and District Area Committee held on 18 April 2013) dated 19 March 2013 by the Head of Planning and Development advising of progress in relation to the Bellshill Town Centre Action Plan and in particular (1) detailing the progress of the survey and consultation work associated with the Bellshill Town Action Plan, which was scheduled for completion by autumn 2013; (2) advising of damage, as a result of vandalism, to the works which had been undertaken at James Dempsey Way; (3) pointing out that resolution of the minor repair works to some of the paving within the Town Centre streetscape and the vandalism at James Dempsey Way was under consideration; (4) setting out statistical information provided by Town Centre Activities which showed (a) that footfall within the town centre was down in comparison with the same period last year and that this fall was slightly higher than the national average, and (b) that 20 CCTV incidents had been recorded for Bellshill Town Centre in quarter 3 of 2012/2013; (5) indicating that various events, as detailed within the report, were planned for or had taken place within the Bellshill Town Centre area, and (6) providing details of progress regarding the establishment, within the town centres, of Business Improvement Districts, with awareness events having been held in Airdrie and Motherwell.

David Sutton, Assistant Business Manager (Development Implementation) was then heard in supplement to the report and in response to Members' questions, when he outlined the consultation procedures for the new Town Centre Action Plan and indicated that the results of the traffic modelling exercise would be available shortly.

Decided: that the progress made on the projects and initiatives within the Bellshill Town Centre Action Plan be noted.
