DECLARATIONS OF INTEREST IN TERMS OF THE ETHICAL STANDARDS IN PUBLIC LIFE ETC. (SCOTLAND) ACT 2000

1. The Local Area Partnership noted that there were no declarations of interest.

NORTH LANARKSHIRE'S YOUTH INVESTMENT PROGRAMME – UPDATE

2. With reference to paragraph 2 of the Minute of the meeting of the Local Area Partnership held on 1 August 2013, there was submitted a report (docketed as relative to the meeting of the Bellshill and District Area Committee held on 23 January 2014) dated 10 December 2013 by the Executive Director of Regeneration and Environmental Services (1) setting out the background to, and details of, the Youth Investment Programme which offered employers an incentive to recruit young, unemployed residents of North Lanarkshire and had a target of 5,000 unemployed residents to be brought back into work over the three year period of the Programme; (2) indicating that, by November 2013, 1,510 unemployed residents had benefited from the Youth Investment Programme; (3) outlining the position for the Partnership area, with 202 supported into employment, 61 from the Bellshill Ward, 87 from the Mossend and Holytown Ward and 54 from the Thorniewood Ward; (4) detailing ways in which the Local Area Team could assist in delivering the objectives of the Programme and maximise the benefit of the Youth Investment Programme, and (5) concluding that, while the Youth Investment Programme had made encouraging early progress, Regeneration Services required the support of all stakeholders and partners to make the Programme a success and welcomed feedback from partners on ways in which the Programme could be improved.

Thereafter, the Local Area Partnership heard Ian Hunter, Economic Development Officer in supplement to the report.

Decided: that it be recommended to the Area Committee:-

- (1) that the content of the report be noted, and
- (2) that the report be referred to the Local Area Team for action to ensure that the most disadvantaged communities maximise benefit from the Youth Investment Programme.

PRESENTATION ON PROPOSALS FOR A SPORTS HUB AT BELLSHILL ACADEMY

5. Duncan McLeod, Convener of the Bellshill and District Community Forum introduced Colin MacFarlane of Active Bellshill Community Group and the Local Area Partnership heard him in relation to (1) the background to the setting up of the Community Group and their aims and objectives; (2) proposals for the creation of a Sports Hub within Bellshill Academy, including details of possible funding sources and income; (3) the key benefits of the proposals, and (4) details of the proposed timetable to take forward the proposals.

Mr. MacFarlane and other members of the Group who were present at the meeting then answered questions by Members and, thereafter, the Convener thanked them for an interesting and informative presentation and indicated that a report on proposals for a Sports Hub at Bellshill Academy was due to be submitted to the Learning and Leisure Services Committee on 4 February 2014.

Decided: that the content of the presentation be noted.

NORTH LANARKSHIRE PARTNERSHIP BOARD MINUTES

6. There were submitted the Minutes of the meetings of North Lanarkshire Partnership Board held on 17 July and 11 September 2013.

NHS LANARKSHIRE – NORTH COMMUNITY HEALTH PARTNERSHIP – NORTH EAST UNIT

7. There was submitted a report (docketed as relative to the Minute of the meeting of the Bellshill and District Area Committee held on 23 January 2014) dated 6 January 2014 by the Service Manager, NHS Lanarkshire – Bellshill Locality providing details of various matters which had been considered or had taken place within the Bellshill Locality since the last meeting of the Local Area Partnership, including (1) the up-to-date position regarding the John Street Practice; (2) Sexual Health Services for Vulnerable Young People; (3) the First Steps Programme North Lanarkshire which aimed to tackle health inequalities in the early years of a child's life; (4) the Child Health Surveillance 27-30 month review, and (5) the Family Nurse Partnership, the aim of which was to assist first time mothers under 20 years of age.

The Chair then undertook to contact NHS Lanarkshire with a view to obtaining further details regarding the progress of the new clinic building for the John Street Practice and to report back on the outcome to the next meeting of the Local Area Partnership.

Decided:

With reference to paragraph 9 of the Minute of the meeting of the Local Area Partnership held on 24 October 2013, there was submitted a report (docketed as relative to the Minute of the meeting of the Bellshill and District Area Committee held on 23 January 2014) dated 23 January 2014 by the Head of Planning and Regeneration (1) providing information in relation to the priority area, identified within the Bellshill and District Locality, as Ward 15 – Mossend and Holytown; (2) setting out, within Appendix 1 to the report, (a) information and actions, considered by the Local Community Safety Sub-Group, for the period from 1 September to 30 November 2013, including a "hot spot" map which highlighted crime and anti-social behaviour issues within the priority ward area; (b) statistical analysis of incidents in the area; (c) the Partner Action Plan for the area which provided a summary of agreed actions to address some of the issues identified, and (d) statistical information in relation to the two remaining wards within the Bellshill and District Locality; (3) summarising issues that arose over the December/Christmas period, as set out within Appendix 2 to the report, and (4) detailing, within the report, action taken to promote positive outcomes within the Locality.

The Local Area Partnership then heard Alison Clarke, Area Housing Manager, Group Commander Paul Devlin, Scottish Fire and Rescue Service and Chief Inspector Rosie Wright, Police Scotland in supplement to the report and in response to Members' questions.

REMODEL OF THE ANTI-SOCIAL BEHAVIOUR SERVICE

12. There was submitted a report (docketed as relative to the Minute of the meeting of the Bellshill and District Area Committee held on 23 January 2014) dated 13 December 2013 by the Head of Housing Services (1) intimating that a Member/Officer Working Group had been set up to review the way in which the Council and its partners dealt with anti-social behaviour; (2) advising of the main findings of the review, as outlined in the report, which had been submitted to the Member/Officer Working Group and the main Service Committee, and (3) setting out, within the report, the new Service Model which had been approved and which was due to formally launch on 1 April 2014.

The Local Area Partnership then heard Stephen Llewellyn, Operations Manager in supplement to the report and in response to questions from Members, when he indicated that the formal launch of the new Anti-Social Behaviour Service was now scheduled to take place on 3 April 2014.

BELLSHILL TOWN CENTRE ACTION PLAN – UPDATE

13. With reference to paragraph 11 of the Minute of the meeting of the Local Area Partnership held on 24 October 2013, there was submitted a report (docketed as relative to the Minute of the meeting of the Bellshill and District Area Committee held on 23 January 2014) dated 19 November 2013 by the Head of Planning and Regeneration (1) advising of progress in relation to the development of the Town Centre Framework and Action Plan; (2) reiterating that no funding had been allocated in the Capital Programme for Bellshill Town Centre, with the consequential requirement that opportunities for external funding would need to be identified within the new Framework and Action Plan; (3) advising that 38 actions had been identified within the Town Centre Action Plan prepared by the Scottish Government as part of the National Review of Town Centres which aimed to stimulate, encourage and support action across the public, private and community sectors through partnership action at a local level and which would be developed through the Town Centre Framework and Action Plan for Bellshill, and (4) setting out statistical information provided by Town Centre Activities Limited for all the Partnership areas which showed (a) that Bellshill's vacancy rate of 9.6% was below the Scottish average of 11.1%, and (b) that footfall within the Town Centre was down in comparison with the same period last year.

The Local Area Partnership then heard Shirley Penman, Senior Planning officer, in supplement to the report and in response to Members' questions when she advised that the scaffolding at Hamilton Road had now been removed.

Decided: that the progress made on the projects and initiatives contained within the Bellshill Town Centre Action Plan be noted.
