## 1.0 INTRODUCTION

- 1.1 The purpose of this report is to keep Committee Members informed of the above.

## 2.0 BACKGROUND

- 2.1 Following instructions from the Client Department, tender documents were prepared for the removal of existing single glazed metal windows and curtain wall sections and replacement with UPVC section double glazed windows with generally ventilated casements where indicated and curtain walling sections, complete with UPVC internal insole facings, timber internal sill and apron, all associated ironmongery, decoration work to timber, silicon mastic all round internally and externally and all making good of existing structure and decoration internally and externally.
- 2.2 The funding for this work is contained within the Education Capital Major Maintenance Programme 2004/2005 and 2005/2006.

## 3.0 PROPOSALS/CONSIDERATIONS

- 3.1 The tender documents were issued to five Contractors all of whom submitted Tenders as follows: -
