Site Surplus to Education Requirements at Kyle Road, Cumbernauld

Report by the Director of Education

1. BACKGROUND

- 1.1 The autism unit at Cumbernauld High School is currently located in the home economics wing of the school. As part of the capital building programme, the education committee approved the internal relocation of this unit to newly adapted accommodation.
- 1.2 The education Psychological Service is located in a stand alone facility at Kyle road, Cumbernauld. It is proposed to redeploy the vacant accommodation in Cumbernauld High to provide office accommodation for this service It is expected that the adaptations will be completed by March 2007.
- 1.3 Cumbernauld High is more centrally located and has better transport links which will make it easier for any visitors to access the service. The relocation of this service into Cumbernauld High School will also result in an annual saving of £67,000.
- 1.4 The education resources sub-committee is requested to note that the Kyle Road premises are also used by a senior citizens group and it is therefore proposed to refer this report to the community services sub-committee so that alternative provision can be made.

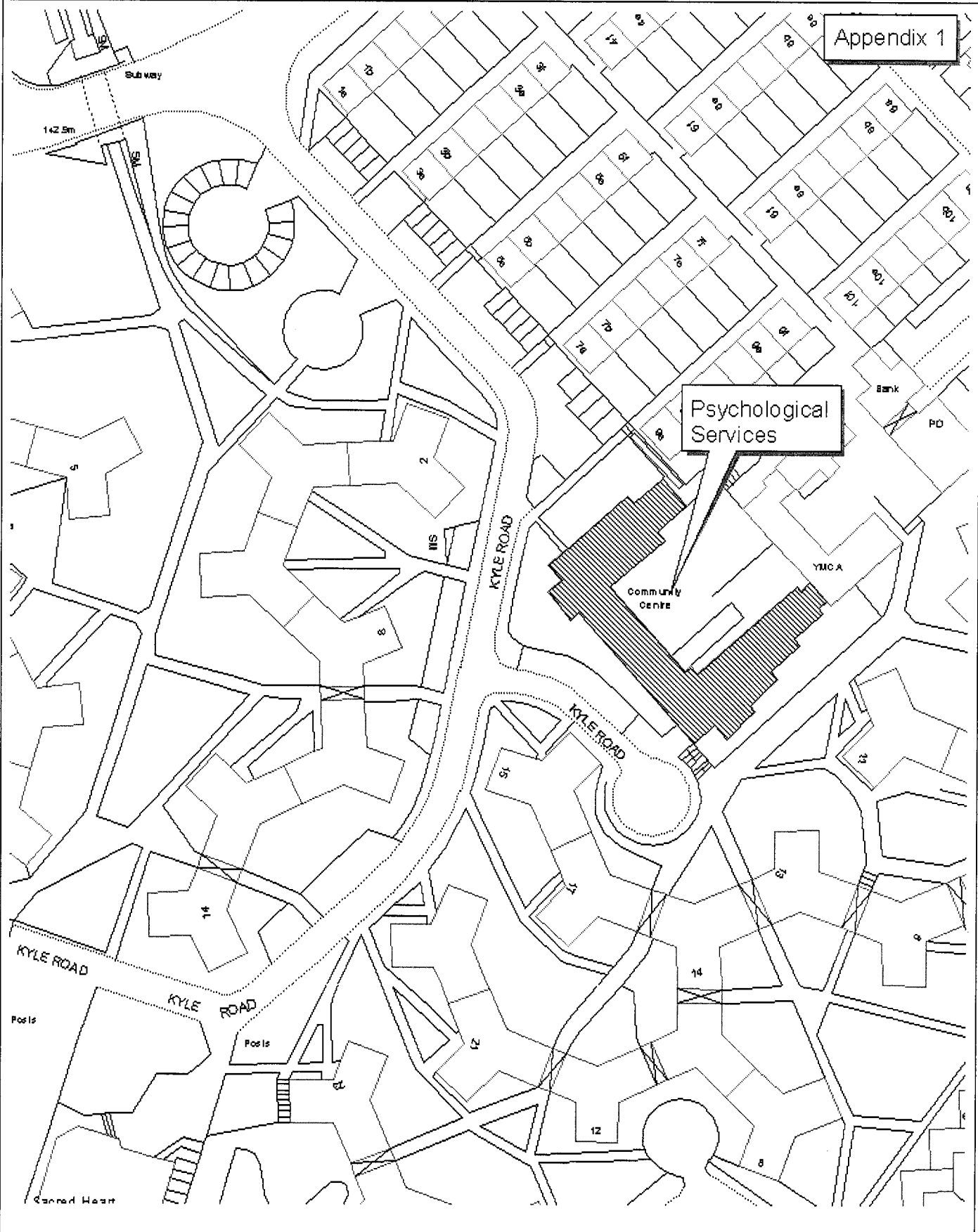
2. PROPOSAL

As a result of the changes described above, the Psychological Services premises at Kyle Road, Cumbernauld will be no longer required by the education department when the new facilities at Cumbernauld High School are completed. It is proposed that the site be declared surplus to requirements.

3. RECOMMENDATIONS

- (a) to declare the site at Cumbernauld Psychological Services, Kyle Road, Cumbernauld as shown in Appendix 1 surplus to the requirements of the education department on completion of the new psychological services facility at Cumbernauld High School.

- (c) to refer this report to the Policy & Resources (Property) sub - committee.
- (d) to refer this report to the Community Services Committee
