**HEARINGS**

**(1) LATE HOURS CATERING LICENCE - NEW APPLICATION - THE BARBEQUE, PER ALVARO PIERI AND GABRIELLE MARCHETTI, 31 LANSDOWNE DRIVE. WESTERWOOD, CUMBERNAULD**

1. The Head of Legal Services advised (1) that an application (tabled) by the Barbeque, per Alvaro Pieri and Gabrielle Marchetti, 31 Lansdowne Drive, Cumbernauld for a Late Hours Catering Licence in respect of the premises at The Barbeque, 27 Tay Walk, Cumbernauld had been received; (2) that letters (tabled) in support of the application had been received from the Clydesdale Bank, CNC Property Management Limited on behalf of the Cumbernauld Centre, and Messrs. Pieruccini-Plant, Accountants and Tax Consultants, and (3) that the application was for additional hours outwith the Council's policy hours.

The Administrative Officer then indicated that Gabrielle Marchetti was not in attendance.

The Sub-Committee then heard the applicants' agent, John Quinn, Wallace Quinn and Company, Solicitors, and Derek Osborne, Assistant Manager, the Cumbernauld Centre speak in support of the application.

Thereafter, Alvaro Pieri, John Quinn, Derek Osborne and representatives of the Police withdrew from the meeting and the Sub-Committee resumed consideration of the matter.

**Decided:** that the application by The Barbeque, per Alvaro Pieri and Gabrielle Marchetti for a Late Hours Catering Licence in respect of the premises at The Barbecue, 27 Tay Walk, Cumbernauld be granted for a period of one year.

**(2) AMUSEMENTS WITH PRIZES GAMING MACHINE PERMIT - NEW SECTION 34 APPLICATION - KEVIN FAGAN, 114 BELHAVEN PARK, MUIRHEAD**

2. The Head of Legal Services advised (1) that a new Section 34 application (tabled) by Kevin Fagan, 114 Belhaven Park, Muirhead for an Amusements with Prizes Gaming Machine Permit had been received, and (2) that objections (tabled) to the application had been received from the Head Teacher, Chryston High School, Chryston Community Council, which Councillor Gray, local Member had indicated his support, and a number of local residents.

The Administrative Officer then indicated that the Head Teacher, Chryston High School and the local residents were not in attendance.

The Sub-Committee then heard Brian Elder, Chryston Community Council outline the Community Council's objection to the application and Kevin Fagan speak in support of his application.

**(3) MARKET OPERATOR'S LICENCE - NEW APPLICATION - KILSYTH COMMUNITY COUNCIL PER MARGOT MACMILLAN, 1 STIRLING ROAD, KILSYTH, ROB KAY, 104 STIRLING ROAD, KILSYTH AND GORDON LETHAM, 30 KINGSWAY, KILSYTH**

The Head of Legal Services advised (1) that an application (tabled) by Kilsyth Community Council per Margot Macmillan, 1 Stirling Road, Kilsyth, Rob Kay, 104 Stirling Road, Kilsyth, and Gordon Letham, 30 Kingsway, Kilsyth for a Market Operator's Licence had been received, and (2) that an objection (tabled) to the application had been received from Mrs. Howard, local resident.

The Administrative Officer then indicated that Rob Kay and Mrs. Howard were not in attendance.

The Sub-Committee then resumed consideration of the matter in Rob Kay and Mrs. Howard's absence.

**(4) STREET TRADER'S LICENCE - NEW APPLICATION - LINDSEY ROBERTSON, 41 HILLSIDE, CROY**

The Head of Legal Services advised (1) that an application (tabled) by Lindsey Robertson, 41 Hillside, Croy for a Street Trader's Licence to enable her to trade from her static snack van at the picnic area at Auchinstarry Quarry, Kilsyth had been received, and (2) that an objection (tabled) to the application had been received from the Director of Housing and Property Services.
