## A Special Meeting of the GENERAL PURPOSES (LICENSING) SUB-COMMITTEE

The Convener exercised his discretion to vary the order of business as hereinafter Minuted.

### **HEARINGS**

- (1) TAXI DRIVER'S LICENCE COMPLAINT DESMOND STRAIN, 101 MONTALTO AVENUE, MOTHERWELL
- 1. The Chief Solicitor (Licensing) advised (1) that a complaint had been received from British Transport Police, relative to the behaviour of Desmond Strain, 101 Montalto Avenue, Motherwell in relation to a contravention to Scotrail Railways Limited Byelaw 14(2); (2) of the background relative thereto, and (3) that the British Transport Police witnesses were unable to be in attendance.

The Sub-Committee then heard the Chief Solicitor (Licensing) outline the complaint and Desmond Strain speak in respect of the complaint.

Thereafter, Desmond Strain and representatives of the Police withdrew from the meeting and the Sub-Committee resumed consideration of the matter.

Desmond Strain and representatives of the Police were then re-admitted to the meeting.

## (2) PRIVATE HIRE CAR DRIVER'S LICENCE - NEW APPLICATION - DAVID CUNNINGHAM, 76 DUNDYVAN ROAD, COATBRIDGE

With reference to paragraph 1 of the Minute of the Special meeting of this Sub-Committee held on 18 August 2003, the Chief Solicitor (Licensing) advised that consideration of an application (tabled) by David Cunningham, 76 Dundyvan Road, Coatbridge for a Private Hire Car Driver's Licence had been continued to allow the applicant an opportunity to appear before the Sub-Committee to speak in support of his application.

The Sub-Committee then heard the applicant and Superintendent McGuire speak in respect of the application.

Thereafter, the applicant and representatives of the Police withdrew from the meeting and the Sub-Committee resumed consideration of the matter.

# (3) PRIVATE HIRE CAR DRIVER'S LICENCE AND PRIVATE HIRE CAR LICENCE - NEW APPLICATION - JAMES FRASER, 19 HUME DRIVE, BOTHWELL

3. With reference to paragraph 1 of the Minute of the Special meeting of this Sub-Committee held on 11 August 2003, the Chief Solicitor (Licensing) advised (1) that consideration of an application (tabled) by James Fraser, 19 Hume Drive, Bothwell for a Private Hire Car Driver's Licence and Private Hire Car Licence had been continued to allow the applicant an opportunity to appear before the Sub-Committee to speak in support of his application; (2) that a late representation had been received from the Chief Constable, Strathclyde Police, and (3) that James Fraser had spent convictions.
