**MOTHERWELL CITIZENS ADVICE BUREAU**

1. With reference to paragraph 7 of the Minute of the meeting of this Committee held on 28 October 1998, when it was agreed that the invitation received from the Citizens Advice Bureau to give a presentation to this Committee be accepted, the Committee heard the Bureau Manager (1) outline the profile of the Citizens Advice Bureau; (2) detail the various range of services provided in the area; (3) provide information as to the number and type of enquiry which the Bureau received, and (4) detail the financing of the Bureau's activities.
