1. INTRODUCTION

1.1 The purpose of the report is to recommend acceptance of a tender from J. H. Civil Engineering Ltd. for the "Capital Roads Resurfacing Works Northern Area 2005 – 2006" Contract.

2. BACKGROUND

2.1 Briefly the works comprise the resurfacing of various carriageways within the Northern Area of North Lanarkshire Council and includes patching, kerbing, drainage and traffic management. Tenderers were advised that, notwithstanding the amount tendered, the Contractor appointed should expect to be given between £450,000 and £650,000 worth of work.

2.2 Funding for this work is contained within the Planning & Environment Roads Capital Budget for 2005 - 2006 under the heading of Road and Footway Refurbishment Programme.

3. CONSIDERATION

3.1 The tender documents were issued to six Contractors, as follows:

3.2 The project costs, based on budget values, are highlighted below:

- 3.3 The tender of £357,178.50 submitted by J.H. Civil Engineering Ltd. has been consistently and competitively priced and is worthy of consideration for acceptance.
- 3.4 The works are to be executed on land wholly owned by N.L.C.
- 3.5 The Pre-Tender Health and Safety Plan has been prepared by the Planning Supervisor and issued to all tenderers. The construction Phase Health and Safety Plan will be developed by the appointed Contractor prior to commencement of work on site.
- 3.6 Project management arrangements will be introduced to achieve cost effective project completion.

4. RECOMMENDATION

- 4.1 It is recommended that Committee authorises the Director Of Administration to accept the tender submitted by J. H. Civil Engineering for the "Capital Roads Resurfacing Works Northern Area 2005 - 2006" Contract
